Sub: Extension of Cut-off Date in relation to the consent solicitation (the “Consent Solicitation”) in respect of the U.S.\$546,916,000 Step Up Convertible Bonds due 2019 issued by Suzlon Energy Limited (the “Existing Bonds”).
