Sub: Outcome of Board Meeting

In continuation to earlier letter for outcome of Board Meeting sent today, please note that the Board of Directors of the Company have, *inter alia*, considered and approved the following:

1. Re-constitution of Board

Appointment of Mr. Anandakrishnan Chandrasekaran as an Additional Independent Director.

Based on the recommendation of Nomination and Remuneration Committee, Mr. Anandakrishnan Chandrasekaran. (DIN: 08535001) has been appointed as an Additional Independent Director on the Board of the Company with effect from August 10, 2019, for a term of five years. Approval of the Members of the Company for the said appointment shall be sought at the next General Meeting of the Shareholders of the Company.

Mr. Anandakrishnan Chandrasekaran holds an M.S. in Electrical Engg. from Stanford University, and a B.S. in Communications Engg. from PSG College of Technology (India). In 2010, he was named Young Global Leader by World Economic Forum. In 2016 and 2017, Mr. Anandakrishnan Chandrasekaran was named to Fortune's '40 under 40' list in India.

Mr. Anandakrishnan Chandrasekaran has worked on/led six products globally with over 10M active users across commerce, messaging, financial services & content discovery with one app over 1 billion users and two others over 50M. He is also an entrepreneur having co-founded & built Aeroprise Inc.

Most recently he was Director of Platform / Product Partnerships for Messenger at Facebook, leading the growth of the platform to 250,000+ active developers and over 8B messages between businesses and consumers.

He was previously Chief Product Officer @ Snapdeal, one of India's earliest e-commerce unicorns, valued at \$6.5B. Previously, he was CPO at Bharti Airtel, the #3 mobile operator globally with 300M subscribers driving new product development and launching Wynk Music, Airtel Money etc. and leading the e-commerce business.



Earlier, Mr. Anandakrishnan Chandrasekaran was with Yahoo!, where he held roles of Sr. Director for Search and Mobile. Previously, he co-founded Aeroprise. Aeroprise became the most-deployed solution worldwide for mobile service management, raised \$7M in funding and was acquired by BMC Software.

Mr. Anandakrishnan Chandrasekaran is also one of the most successful early stage investors in technology startups - having done over 35 investments including Rupeek, MoEngage, NoBroker, Lucideus, Tonetag, Yulu Bikes in India and Silicon Valley tech startups like Chatfuel, Nexkey and Fiddler.Al.

Mr. Anandakrishnan Chandrasekaran is not related to any of the Directors or Key Managerial Personnel or Promoters of the Company.
