With reference to the earlier announcement dated 28<sup>th</sup> June, 2021, pursuant to the provisions of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015, this is to inform you that, due to unavoidable circumstances, the Meeting of Board of Directors which was scheduled to be held on 07<sup>th</sup> July, 2021 i.e today is now postponed and re-scheduled to be held on Thursday, 15<sup>th</sup> July, 2021, inter alia, to consider, approve and take on record the Audited Financial Results of the Company for the Quarter and Year ended on March 31, 2021.

In accordance with the applicable Regulations of SEBI (Prohibition of Insider Trading) Regulations, 2015, the trading window for dealing in the securities of the Company for insiders which closed on Thursday 1<sup>st</sup> April 2021 would have in the normal circumstances after 48 hrs of declaration of Financial Results of the Company for the Quarter and Year ended on March 31, 2021. However, in respect of quarter ended June 30, 2021, the trading window would again closed on Thursday 1<sup>st</sup> July 2021. Hence, there would be no reopening of the trading window which shall remain closed again from Thursday, 1<sup>st</sup> July 2021.
