This is with reference to our letter dated June 09, 2023, we have informed that the KWE Group has sold the 30% stake held in Gati-Kintetsu Express Private Limited ("GKEPL"), material subsidiary of the Company to Allcargo Logistics Limited ("Parent Company"). The transaction was completed on June 08, 2023.
