### GHCL announces financial performance for Q4/ FY24 (Standalone)

**New Delhi, 06<sup>th</sup> May 2024:** GHCL Limited, India's leading Chemical Company, today announced its financial results for Q4 FY24.

**Commenting on the financial performance, Mr. R S Jalan, MD, GHCL Limited said “**

#### Q4 FY24 VS Q4 FY23 (Standalone Performance)

- **Net Revenue declined** to Rs. 840 Crores as compared to Rs. 1,141 crores in the corresponding quarter ended March 31, 2023 mainly due to decline in realization of soda ash prices on account on higher imports into India.
- **EBIDTA declined** to Rs. 201 Crores as compared to Rs. 370 crores in the corresponding quarter last year mainly due to lower realization
- **Net Profit (PAT) from continued operations declined** to Rs. 125 Crores as against Rs. 251 crores in the corresponding quarter last fiscal.

#### FY24 VS FY23 (Standalone Performance)

- Revenue declined by 24% to Rs. 3,498 Crores in FY24 as against Rs. 4,584 crores in FY23
- EBIDTA declined by 41% to Rs. 899 Crores in FY24 as against Rs. 1,519 crores in FY23
- Profit After Tax from continued operations declined by 27% to Rs. 793 Crores as against Rs. 1,092 crores in FY23
