Game Zone fire: SIT records statements of 5 more RMC officials

KAMAALSAIYED SURAT, MAY 31

THE SPECIAL Investigation Team (SIT) probing the TRP Game Zone fire. which killed 27 people on May 25, recorded statements of five more officials of Rajkot Municipal Corporation (RMC) Friday and took into custody documents related to the gaming zone.

Speaking to The Indian Express, SIT chief Subhash Trivedi said, "We have so far questioned nine officials. We have also recovered documents related to the TRP Game Zone from those who were questioned today. We are looking into their role and other aspects of

the incident. A few more will also

be questioned and several docu-

ments are yet to be recovered."

"Further, we are taking inputs from our team member, Commissioner(Technical Education)BN Pani, who had served as the Surat municipal commissioner during the Takshashila Arcade fire (in May 2019) to understand what steps the civic body took after the tragedy," he added.

The RMC officials questioned on Friday included assistant town planner Mukesh Makwana, assistant engineer Rudrawadi Aasi as well as firemen Jayesh Dabhi and Gautam Faflana, said sources in the SIT.

The SIT had on Thursday questioned Rajkot chief fire officer Ilesh Kher. fire officer Rohit Vigora and former Rajkot taluka police inspectors VS Vanzara and VJ Dhola. Vigora was arrested also by the Rajkot Crime Branch on Thursday.

DEO conducts surprise inspections at Surat schools

EXPRESS NEWS SERVICE SURAT, MAY 31

MORE THAN 106 teams, comprising education officers and technical teams from Surat District Education Officer (DEO), carried out surprise inspections across schools in Surat city on Thursday. The drive to check the safety of

school buildings comes following a May 27 circular issued by the Surat DEO to all grant-in-aid and non grant-in-aid primary and secondary schools in the city to get a fire NOC and building use (BU) permission from the civic body in the aftermath of the Raikot TRP Game Zone fire. There are over 2,500 grant-in-aid and non grantin-aid schools in Surat city.

"Apart from fire NOC and BU permission, our teams are also checking whether the schools have CCTV facilities and if they are in working condition. The teams

instructed the school authorities to recheck the school electrification network as the new academic year will start shortly and even monsoon is at the door steps. During monsoon, there is an increased likelihood of electric short-circuits. We have also told schools to implement norms of School Safety policy, 2016," Surat DEO Bhagirathsinh Parmar said.

The teams inspected more than 900 schools since the launch of the drive Thursday. Many schools were found to lack a fire NOC and BU permission issued from the Surat Municipal Corporation (SMC).

"We have found many schools do not have BU permission and fire NOC in Surat city. Once the entire drive is completed, we will share information with the SMC authorities to take further steps," he said, adding, "Once we finish the process in Surat city, we will cover the schools in the district."


As complainant Sanjay Solanki, city unit chief of NSUI – a Congress-affiliated organisation is a Dalit, the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, too, was invoked. "No one has been arrested yet," said Inspector V J Savaj of Junagadh A Division police station.

As per the FIR, Solanki asked Jadeja to drive carefully Thursday night when the latter's car passed too close to Solanki's two-wheeler

in Kalva Chowk. Angered, Jadeja and his associates followed Solanki to his residence but left after Solanki's father, who knew Jadeja, intervened. When Solanki went out on his

two-wheeler around 3 am, a car with Jadeja's men in it allegedly rammed it from behind. As Solanki fell to the ground, five men stepped out, allegedly beat him with sticks, and put him in the car.

He was taken to Jadeja's residence where he was thrashed and asked to guit the NSUI, the complainant said. In the morning, the accused dropped Solanki at Bhesan crossroads, said the FIR.
