Opinion

Basis for Opinion

2 Attention is also drawn Note 3 where subsidiary R S Software Asia Pte has applied for Strike off on 01/04/2020 with ACRA (Accounting and Corporate Regulatory Authority), Singapore.

Our opinion is not modified in respect of point no. 1 and 2 as mentioned under above paragraphs

Management's Responsibilities for the Standalone Financial Results
