Please note that the Company has received a Show Cause Cum Demand Notice from the Commissioner of GST Intelligence, Gautam Budh Nagar, Greater Noida 201306 under section 16 of the Central Goods and Services Tax Act, 2017 ("the Act"), on October 04, 2023 alleging a tax demand of ₹ 20.26 Crores/- in addition with the an equivalent penalty of Rs. 20.26 Croes/- and applicable interest on the said demand.

The alleged demand and the impugned Show Cause Cum Demand Notice pertains to account of wrong availment of transitional input credit and other wrong availment of input tax credit of GST.

The Company will be filing appropriate response to the said Show Cause Cum Demand Notice within the prescribed timelines.
