Sub: Intimation for rescheduling of Board Meeting and Closure of Trading Window

- In terms of Regulation 29(1)(e) & 29(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 it may be noted that at the abovementioned meeting, the Board of Directors may also consider recommending dividend on the Equity Share Capital of the Company for the financial year ended 31st March, 2019, which subsequently upon declaration by the shareholders at the ensuing Annual General Meeting, would be paid to the shareholders of the Company within 30 days from the date of such declaration.

In furtherance to our earlier intimation dated 3rd April, 2019, we hereby inform that as per the Company's "Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and immediate relatives of Designated Persons", framed pursuant to the provisions of SEBI (Prohibition of Insider Trading) Regulations, 2015, the "Trading Window" of the Company has been closed for "Designated Persons" and "Insider" from **Thursday**, **4**th **April**, **2019** and the same shall remain closed till 48 hours after the financial results are approved at the Board meeting and become generally available.
