With the objective of achieving economies of scale, optimising production processes and reducing overall operating expenses, the Company, during the quarter ended 30 June 2023, relocated its labels manufacturing capacities at three sites to other existing label manufacturing sites. Pursuant thereto, the Board, at their meeting held on October 17, 2023, granted approval for closure of the Company's labels manufacturing sites at Sikkim, Daman and Hyderabad respectively. Relevant information has been shared in the Notes to Accounts during the quarter and half year ended June 2023. None of the closures are material from a materiality threshold perspective.
