SUB. REVISED DISCLOSURE UNDER REGULATION 31(1) AND 31(2) OF SEBI (SAST) REGULATIONS, 2011 FILED DATED 29.04.2022

This is with reference to the above captioned subject we “Max Ventures Investment Holdings Private Limited” (“the Company”) had filed a disclosure dated 29.04. 2022 for a pledge of 6,40,000 shares against a facility availed from SKS Fincap Private Limited dated 25.04.2022.
