### GCA to sell offline tickets for Nov 4, Nov 10 matches

Ahmedabad: The Gujarat Cricket Association (GCA) has decided to sell offline tickets for the remaining round-robin matches of the ICC Men's Cricket World Cup 2023 being held in Ahmedabad. The GCA said in a statement. The Narendra Modi Stadium is set to host Australia vs England on November 4, followed by South Africa vs Afghanistan on November 10. The tickets, the statement added, for both the matches will be available from October 24 to 30 at the ticket counter of the Narendra Modi Stadium and from October 31 to November 4 at the Sardar Patel Stadium in Navrangpura from 10 am to 5 pm. Andhra thrashed Gujarat by 8 wickets in the Syed Mushtaq Ali T20 Trophy in a Group 'C' clash, in Ranchi on Saturday. Gujarat were bowled out for 165 in 19.2 overs, in reply to which, Kona Bharat's 60 helped Andhra ace the chase in 17.4 overs for the loss of two wickets. Strong wins at Ekana Stadium in Lucknow during the World Cup match between Australia and Sri Lanka caused advertising hoardings to fall onto empty seats.

Ahmedabad, A recently conducted survey by The Association of Physicians in India (API) and Ipsos, in 16 cities among adults aged 50 years and older, their caregivers and doctors has yielded compelling insights into why there is low adoption of adult immunisation in India. The survey shows that although 71% of adults aged 50 years are aware of adult vaccination, only 16% have taken any adult vaccines. Patients and doctors have provided significantly different reasons for low adoption. A majority of doctors surveyed (90%) state that a lack of formal guidelines results in a lack of interest and adoption of vaccination by patients. Doctors also hesitate to discuss adult vaccination with their patients because they have limitations of time, and they also feel patients are less receptive to vaccination recommendations.

Ahmedabad, NHA I upgraded ATMS standards and specifications 2023 for deploying Artificial Intelligence (AI) to improve road safety. But till date there is no single road in the country having complete automated enforcement ATMS system. New Delhi October 26, 2023 Road Safety experts expressing concern over increasing road accident deaths in the country have stressed on the need of embedding road safety features at the stage of planning and designing of roads and ensuring its implementation by the road infrastructure companies for making safer and better roads in the country. "India accounts for more than 11 per cent of the global road accident deaths mainly due to absence of safety measures. Many fatalities and serious injuries on Indian roads could have been saved if several recommended road safety actions had been implemented, United Nations has set a global 'Decade of Action' plan for Road Safety which aims to reduce road fatalities by 50 per cent till 2030 and Indian Road Transport and Highway Minister Mr Nitin Gadkari has set year 2025 as target for reducing road deaths by 50%," said Mr P.K.
