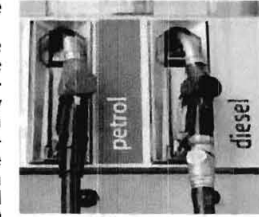

Oil marketing companies (OMC) continue to pouse fuel price revision for the 24th consecuti day on Tuesday as wait and watch continue amk the fluctuating global crude prices.  
Global crude prices have swung in all di rections in July starting with a low of \$70 a bar rel to quickly rise to over \$77 a barrel, only to fall soon below \$70 a barrel and crossing \$75 a barrel later in the month. The o prices have softened again to under \$70 a barrel o the concerns of growing Covid cases, lockdowns i China, slowing industrial recovery globally and ris ing US oil inventory.  
With no price increase by OMCs, in the nationa capital, petrol continues to be sold for Rs 101.84 pe litre, while diesel is also being sold at the unchange price of Rs 89.87 a litre on Tuesday. The pump pric of fuel has been static since July 18. In the city o Mumbai, where petrol prices crossed the Rs 100
