UEFA Champions League: Chelsea coach Graham Potter says Fikayo Tomori red card changed the game

New Delhi. Chelsea head coach Graham Potter has said the Fikayo Tomori's red card changed the game for Chelsea at San Siro. Pierre-Emerick Aubameyang and Jorginho scored to give Chelsea a 2-0 win over AC Milan in the UEFA Champions League. The newly appointed head coach insisted that the penalty was a big moment in the game and changed what Milan could do. "Firstly, to get a penalty and then a red card is a big moment (in the match). Everybody would agree with that as it changes the game in terms of what Milan want to do. For us, we still have to make it count and it isn't straightforward playing against 10 men, especially here as any action can lead to a goal and then the crowd are so into the game again. So it's really difficult. It was a big moment but I felt we could do enough 11 v 11. But the referee has made a decision and we have to get on with it," said Potter. The Englishman also touched upon Reece James, who picked up an injury against the Italian champions.

"Reece, we're hoping he'll be ok. (We'll need) 24-48 hours because it's too early to tell you anything more than that," Potter added.

Potter also showered praise on Aubameyang, saying it looks like he's enjoying his football and scoring goals.No, we've not done anything special, it's all down to him. He has been building his fitness up. We spoke before that he came from a difficult summer so it's been a case of building up his match minutes up and the more he gets the stronger he gets, and the more we understand him the more he understands us. Everyone knows his quality and it's great for him. He looks like he is enjoying his football and scoring goals is important," said Potter.

Chelsea registered their fourth win in a row under new manager Graham Potter. With this win, the Blues moved above RB Salzburg into first place in their group in the UEFA Champions League.

Mahela Jayawardena draws similarities between Wanindu Hasaranga and Lasith Malinga: They have similar mannerisms

New Delhi. Mahela Jayawardena stated that Wanindu Hasaranga and Lasith Malinga have "similar mannerisms" as the two started off shy before blossoming into cornerstones.

Jayawardena has known Hasaranga since he was 19 years old, thanks to his former teammate and Hasaranga's brother, Chaturanga de Silva."The way he has blossomed hes also from down south, quite close to where Lasith was (Galle) and they have similar mannerisms," Jayawardena said on ICC Review."The way they both came out, they started their careers quietly you know, sat in the corner of the dressing room and little by little they grew. The hairstyles change, the tattoos came out and the whole thing."Jayawardena further said that Hasaranga and Malinga are also fierce competitors. "It (Hasarangas development) is quite similar to how Lasith became who Lasith was, and thats how I see the way Wanindu has blossomed as a player. The most important thing is, once they cross the field, like Lasith, he is a competitor thats what I love about him."Hasaranga played a crucial role for Sri Lanka during the 2021 T20 World Cup, taking 16 wickets to finish the tournament as the highest wicket-taker. He then backed his form at the recent 2022 Asia Cup, picking up nine wickets and hitting 66 runs, which included his all-round brilliance (36, 3/27) against Pakistan. All of Hasaranga's recent outings have convinced Jayawardena that Hasaranga has the leadership qualities to go with his craft.

"In the last 12 months, he has shown how mature he is not just as a bowler but with the bat as well. In tough situations, he has really come and delivered," Jayawardena said.

ODI cricket debate: 10 overs in middle need to be scrapped and make it a bit more interesting, says Adam Zampa

New Delhi. Australia legspinner Adam Zampa offered suggestions to make ODI cricket a "bit more interesting", saying 10 overs in the middle should be scrapped as the debate over the future of the 50-over format continues within the cricketing community.

"There's about ten overs in the middle that need to be scrapped or something needs to be done with them, something a bit more exciting" Zampa told ABC Sport. "Or in between overs 20 and 30, there could be bonuses or extra free-hits, or something like that... make it a bit more interesting."

The debate heated up earlier in July when Ben Stokes stunned the cricketing fraternity with his retirement from ODI cricket. Since then, a number of players have come forward to provide their version of modification to make the 50-over game exciting. However, there are some cricketer who have no problem with ODI cricket. Zampa's teammate Ashton Agar is against the modifications, saying: "I like ODI cricket, it is just enough time to do enough."

"You know, ten overs [per bowler] is a lovely amount of bowling time. Fifty overs is a good time to bat, like it gives the guys lower down the order a bit of time if there's a few wickets that have fallen. Yes, I think people get frustrated at, maybe it gets a bit too long, but I think that's just because of the advent of T20 cricket. So, I like ODI cricket."Alex Carey echoed Agar's words and added "there's still lots of room in the game for one-day cricket for sure".
