# पोंजी घोटाले में 4,109 करोड रुपए की संपत्तियां कुर्क

नई दिल्ली, 24 दिसंबर (भाषा)।

प्रवर्तन निदेशालय (ईडी) ने पोंजी घोटाले से जुड़े धनशोधन के मामले में विभिन्न राज्यों में 4,109 करोड़ रुपए की संपत्तियां कुर्क की हैं। एजंसी ने गुरुवार को यह जानकारी दी। यह मामला एग्री गोल्ड ग्रुप ऑफ कंपनीज से जुड़ा है। कंपनी के तीन प्रवर्तकों को केंद्रीय एजंसी ने मंगलवार को गिरफ्तार किया है।

ईडी ने बयान में कहा कि कुर्क की गई संपत्तियों में 2.809 जमीनी संपत्तियां. आंध्र प्रदेश में 48 एकड़ में फैला हेलैंड एम्यूजमेंट पार्क, जो अरका लेजर एंड एंटरटेनमेंट्स प्राइवेट लिमिटेड के नाम है, के अलावा विभिन्न कंपनियों के शेयर, संयंत्र और मशीनरी शामिल हैं। इन संपत्तियों को धनशोधन रोधक कानून (पीएमएलए) के तहत अस्थायी तौर पर कुर्क किया है। ये संपत्तियां आंध्र प्रदेश, कर्नाटक, ओड़ीशा, तमिलनाडु और तेलंगाना में हैं।

अभियुक्त ईडी के आदेश के खिलाफ पीएमएलए के न्याय निर्णय प्राधिकरण के समक्ष छह माह में अपील कर सकते हैं। ईडी ने आरोपियों के खिलाफ आंध्र प्रदेश, तेलंगाना और कर्नाटक में दर्ज पुलिस प्राथमिकी के आधार पर जांच की है। इन लोगों पर 32 लाख निवेशकों से 6,380 करोड़ रुपए जुटाकर उनके

साथ धोखाधड़ी का आरोप है। इस मामले में मुख्य आरोपियों एग्रो गोल्ड ग्रुप ऑफ कंपनीज के प्रवर्तकों अवा वेंकट रामा राव, अवा वेंकट एस नारायण राव और अवा हेमा सुंदर वारा प्रसाद को ईडी ने गिरफ्तार कर लिया है।

ओड़ीशा, तमिलनाडु, महाराष्ट्र, अंडमान निकोबार द्वीप समह और छत्तीसगढ के निवेशकों को भी चूना लगाया गया है। एजंसी ने कहा कि इस घोटाले का सूत्रधार अवा वेंकट रामा राव है। उसने एग्री गोल्ड ग्रुप ऑफ कंपनीज के जरिए यह घोटाला किया है, पहले वह गोल्डन फॉरेक्स सीआइएस (सामूहिक निवेश योजना) में काम कर चुका है जहां उसने इस तरह की योजनाओं के बारे में समझा और बाद में पूरी योजना बनाकर यह घोटाला किया।

ईडी ने कहा कि रामा राव ने अपने सात भाइयों और अन्य सहयोगियों के साथ मिलकर 150 से ज्यादा कंपनियां बनाई और आम जनता से पैसा जुटाना शुरू किया। आरोपियों ने निवेशकों को उनके पैसे के बदले प्लॉट/कृषि भूमि या निकासी पर ऊंचा रिटर्न देने का प्रलोभन दिया। आरोपियों ने हजारों की संख्या में कमीशन एजंटों के जरिए लोगों को प्रलोभन दिया। इन लोगों ने कुल 32,02,628 निवेशकों

## केरल मंत्रिमंडल ने राज्यपाल से विधानसभा का विशेष सत्र बुलाने की मंजूरी मांगी

तिरुवनतपुरम, 24 दिसंबर (भाषा)।

केरल मंत्रिमंडल ने केंद्र के नए कृषि कानुनों पर चर्चा करने और इनके खिलाफ प्रस्ताव पारित करने के लिए राज्यपाल से 31 दिसंबर को विधानसभा का विशेष सत्र बुलाने की मंजूरी देने की सिफारिश करने का गुरुवार

मुख्यमंत्री पिनराई विजयन ने मंत्रिमंडल के फैसले के बारे में मीडिया को जानकारी दी और कहा कि उनकी सरकार को उम्मीद है कि राज्यपाल विधानसभा के विशेष सत्र के लिए मंजुरी प्रदान कर देंगे। राज्य सरकार ने नए कृषि कानुनों पर चर्चा करने और आंदोलनकारी किसानों के प्रति एकजुटता व्यक्त करने के लिए इससे पहले भी 23 दिसंबर को विशेष सत्र आहत करने की सिफारिश की थी. लेकिन राज्यपाल आरिफ मोहम्मद खान ने इसके लिए अनुमति देने से इनकार कर दिया था। सत्तारूढ वाम लोकतांत्रिक मोर्चा (एलडीएफ) और विपक्षी संयुक्त लोकतांत्रिक मोर्चा (यूडीएफ) ने राज्यपाल के इस कदम की निंदा की थी। हालांकि प्रदेश भाजपा ने राज्यपाल के कदम का स्वागत किया था। विजयन ने संवाददाताओं से कहा 'मुझे उम्मीद है कि राज्यपाल विशेष सत्र आहत करने की स्वीकृति प्रदान कर देंगे। हमारे देश में लोकतांत्रिक प्रणाली के अनुसार, राज्यपाल बहुमत की सरकार के निर्णय को आम तौर पर मंजूरी प्रदान कर देते हैं।'

# पीएफआइ के बैंक खातों में 100 करोड़ रुपए से अधिक आए

## ईडी ने अदालत से कहा, कुछ सालों में आई रकम का बड़ा हिस्सा नकद जमा किया

कोच्चि (केरल), 24 दिसंबर (भाषा)।

पॉपुलर फ्रांट ऑफ इंडिया (पीएफआइ) के खिलाफ धनशोधन मामले की जांच कर रहे प्रवर्तन निदेशालय (ईडी) ने गुरुवार को यहां की एक अदालत को बताया कि उसकी जांच में अब तक इस बात का खुलासा हुआ है कि इस संगठन के बैंक खातों में पिछले कुछ वर्षों में 100 करोड़ रुपए से अधिक आए हैं।

प्रवर्तनन निदेशालय ने पीएफआइ की छात्र शाखा के नेता केए राउफ शरीफ की हिरासत बढ़ाने का अनुरोध करते हुए धनशोधन रोकथाम मामलों के लिए गठित विशेष अदालत के समक्ष यह दलील दी। शरीफ को धनशोधन की जांच के सिलसिले में गिरफ्तार किया गया था। ईडी की याचिका पर विचार करते हुए अदालत ने शरीफ की हिरासत की अवधि और तीन दिनों के लिए बढ़ा दी। उसकी सात दिन की निदेशालय की हिरासत गुरुवार को समाप्त हो

गई थी, जिसके कारण उसे अदालत में पेश किया गया था। प्रवर्तन निदेशालय

अदालत को सौंपे अपने हलफनामे में कहा कि इन रुपए

के स्रोत एवं भुगतान की जांच की जा रही है। जांच एजंसी ने कहा, 'पीएफआइ के खिलाफ की गई जांच में अब तक इस बात का खुलासा हुआ है कि पिछले कुछ वर्षों में इसके बैंक खातों में 100 करोड़ रुपए से अधिक आए हैं और इस रकम का बड़ा हिस्सा नकद जमा किया गया था।'

ईडी ने यह भी आरोप लगाया कि 2013 से पीएफआइ कई अपराधों में संलिप्त रहा है तथा धन अंतरण एवं नकद राशि का जमा किया जाना भी 2014 के बाद से बढा है।

जांच में इस बात का भी खुलासा हुआ है कि संशोधित नागरिकता अधिनियम (सीएए) विरोधी प्रदर्शनों में भी पीएफआइ संलिप्त रहा तथा दिसंबर 2019 से फरवरी 2020 के बीच इस उद्देश्य के लिए धन का इस्तेमाल किया गया था। ईडी ने फरवरी में उत्तर-पूर्वी दिल्ली में हुए दंगों में भी पीएफआइ की भूमिका रहने का जिक्र किया है।

देश की अर्थव्यवस्था विभिन्न अनुमानों की तुलना में तेजी से कोविड-19 महामारी के दुष्प्रभाव से बाहर आ रही है और आर्थिक वृद्धि दर चाल वित्त वर्ष की तीसरी तिमाही में ही सकारात्मक दायरे में आ जाएगी। भारतीय रिजर्व बैंक (आरबीआइ) के अधिकारियों के लेख में यह कहा गया है।

इसमें कहा गया है, 'इस बात के कई साक्ष्य हैं कि भारतीय अर्थव्यवस्था कोरोना महामारी के कारण गहरे गर्त से तेजी से बाहर आ रही है। यह सर्दियों की लंबी छाया से बाहर निकलते हुए सूरज के उजाले की ओर बढ़ रही है... सरकार के मौद्रिक व राजकोषीय प्रोत्साहन उपायों के जरिए अनुमानों के विपरीत अर्थव्यवस्था तेजी से आगे बढ़ रही है।' कोरोना महामारी से प्रभावित भारतीय अर्थव्यवस्था में चालू वित्त वर्ष की पहली तिमाही में 23.9 फीसद की बड़ी गिरावट आई। वहीं दूसरी तिमाही में गिरावट कम होकर 7.5 फीसद रही।
