Dear Sir,

- 1. I, Hitesh J. Gupta, Company Secretary in practice and Partner, Gupta Baul & Associates, Company Secretaries, have been appointed as Scrutinizer by the Board of Directors of AYM Syntex Limited ("the Company") to scrutinize the postal ballot through remote e-voting ("remote e-voting") on the resolution contained in the notice dated 30th January 2021 ("Notice") in accordance with General Circular No. 14/2020, 17/2020, 22/2020, 33/2020 and 39/2020 dated 8th April 2020, 13th April 2020, 15th June 2020, 28th September 2020 and 31st December 2020 respectively, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars") in respect of the resolution contained in the Post Ballot notice dated 30th January, 2021 ("Notice")
- 2. The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As a Scrutinizer, I have to scrutinize the postal ballot through remote evoting.

Management's Responsibility

3. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolutions contained in the Postal Ballot Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility

4. My responsibility as Scrutinizer for remote e-voting process is restricted to issuing a Scrutinizer's Report of the votes cast "in favour" or "against" the resolution contained in the Notice, based on the reports generated from the e-voting system provided by NSDL.

Cut-off date

5. The Equity Shareholders of the Company as on the "cut-off" date, as set out in the Notice, i.e., Friday, 29 January, 2021 were entitled to vote on the resolution as set out in the Postal Ballot Notice and their voting rights were in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date.

6. e-voting process:-

i. The remote e-voting period remained open from Thursday 4th February, 2021 (9:00 a.m. IST) to Friday, 5th March, 2021 (5:00 p.m. IST).

ii. In terms of MCA Circulars, no physical ballot forms were dispatched by the Company and hence no postal ballots were received. The members who have voted on the resolution have voted through remote e-voting facilities.

iii. After the closure of e-voting, the votes cast through remote e-voting were unblocked on Friday 5th March, 2021 in presence of two witnesses who are not in the employment of the Company.

7. I submit herewith the Scrutinizer's Report based on the scrutiny of remote e-voting by the members on postal ballot and votes cast therein based on the data downloaded from the electronic voting system of NSDL:
