Re: Report of Scrutinizer on passing of Special Resolution through Postal Ballot only by way of remote e-voting of Bhagwati Autocast Limited ("the Company")

- The Board of Directors of the Company, by resolution passed on May 30, 2023, has appointed us as Scrutinizer for conducting the postal ballot (e-voting process) for passing the Special resolution as set out in the Notice of Postal Ballot dated May 30, 2023.
- 2. In terms of the General Circular dated April 8, 2020, April 13, 2020, May 5, 2020, June 15, 2020, September 28, 2020, December 31, 2020, June 23, 2021, December 8, 2021, May 5, 2022 and December 28, 2022 issued by Ministry of Corporate Affairs ('MCA Circulars'), the Company had sent this postal ballot notice in electronic form only. The hard copy of this Postal Ballot Notice along with postal ballot forms and pre-paid business envelopes were not sent to the members for the postal ballot in accordance with the requirements specified under the MCA Circulars. Accordingly, the communication of the assent or dissent of the members would take place through the remote evoting system only. To facilitate such members to receive this notice electronically and cast their vote electronically, the Company had made arrangement for registration of email addresses in terms of the MCA Circulars. The Notice had also been placed on website of the Company at www.bhagwati.com and e-voting website of NSDL at www.evoting.nsdl.com and was also available on the website of stock exchange at www.bseindia.com.

## 3. We submit our report as under:

The Notice of Postal Ballot dated May 30, 2023 along with the statement under Section 102 of the Companies Act, 2013 setting out all material facts in respect of the resolution mentioned therein was sent electronically by e-mail to those members whose names appear on the Register of Members / List of Beneficial Owners as on Tuesday, May 30, 2023 ("Cut-Off Date") received from the Depositories and whose e-mail address is registered with the Company/ Registrar and Transfer Agent ("RTA") / Depository Participants / Depositories in compliance with the above referred MCA Circulars.

The Company has completed the dispatch of Postal Ballot Notice by e-mail on June 05, 2023. Physical copies of the postal ballot notice were not dispatched to the members in accordance with the MCA Circulars. The Company has also published Newspaper Advertisement in Business Standard (English) and Jai Hind (Gujarati) respectively, regarding dispatch of Notice of Postal Ballot alongwith Remote E-voting Information and containing all the matters required under Companies Act, 2013 and relevant rules on June 06, 2023.

- 4. The Company has offered E-voting through NSDL and the report contains the details of E-voting only.
- 5. The facility of E-voting remained open from 9:00 a.m. on Wednesday, June 07, 2023 and ended at 5:00 p.m. on Thursday, July 06, 2023.
- 6. We have unblocked the votes cast through remote E-voting in the presence of Mr. Raimeen Maradiya and Ms. Charmi Shah who are not in the employment of the Company. Thereafter, the details containing, inter-alia the list of members who voted "For" or "Against" the resolution were derived from the report generated from the evoting website of NSDL i.e. www.evoting.nsdl.com.
- 7. 28 members representing 2139358 equity shares have cast their votes through e-voting for the resolution set out in the said notice of Postal Ballot and all votes cast upto July 06, 2023 at 5:00 p.m. i.e. the last date and time for e-voting were considered for scrutiny.
