

Gold and Silver prices today: Precious metals record jump on MCX | Check latest rates here

New Delhi. On September 3, 2021, both gold and silver are trading on the higher side of the Multi Commodity Exchange (MCX). Witnessing a hike of Rs 90 or 0.19 per cent, gold futures maturing on October 5, 2021, stand at Rs 47,095 per 10 grams on the MCX. Meanwhile, silver futures maturing on December 3, 2021, are retailing at Rs 63,389 per kg, recording a jump of Rs 79 or 0.12 per cent. Yesterday, gold stood at Rs 47,049 per 10 grams, recording a hike of Rs 4 or 0.01 per cent. Silver was retailing at Rs 63,977 per kg, with a downfall of 0.03 per cent or Rs 16.

Gold and Silver Prices on International Market

As per Reuters, gold prices rose on Friday after the dollar weakened, with investors awaiting the U.S. jobs data to gauge the Federal Reserve's plans to start tapering asset purchases, although for the week, the metal was headed for its first decline in four. Spot gold rose 0.2 per cent to \$1,813.15 per ounce by 0327 GMT and was down 0.2 per cent on a weekly basis. The report suggested that U.S. gold futures were up 0.2 per cent at \$1,815.50. The dollar index fell to a one-month low, bolstering gold's appeal to those holding other currencies. The greenback was headed for a second straight weekly decline. The SPDR Gold Trust, the world's largest gold-backed exchange-traded fund, said its holdings fell 0.2% to 998.52 tonnes on Thursday, the lowest since April 2020. Silver rose 0.2 per cent to \$23.92 per ounce.

Cryptocurrency prices today: Bitcoin retreats after crossing \$50,000, retains strong momentum

New Delhi. Cryptocurrency prices weakened marginally over the past 24 hours, but the momentum remains strong at the moment and investors are expected to end the week with decent trading gains.

Bitcoin, the world's most popular cryptocurrency, was trading marginally higher than its value 24 hours ago, but its valuation has dipped below \$50,000. It was trading at \$49,601.28 at 11:45 am and its market capitalisation stood at \$932.73 billion. The trading volume in the last 24 hours was 1.16 billion. Ether was still going strong as it was trading over 1.30 per cent higher than its price a day ago. It was trading at over \$3,800 and its market capitalisation is close to crossing \$450 billion. The 24-hour trading volume remains similar to Bitcoin. Cryptocurrency highlights | Check yesterday's prices Not just benchmarks but a number of altcoins including Cardano are set to enter the weekend on a high note. While Cardano fell over 3 per cent today, it still remains close to \$3. Commenting on the cryptocurrency market, Edul Patel, CEO and Co-founder of Mudrex, a global algorithm based crypto trading platform, said, "Bitcoin shot past the \$50,000 mark, and this got the crypto investors pumped up. We witnessed volume traded across exchanges shooting up." "Although Bitcoin faced a minor consolidation after the \$50k mark and consolidated, the altcoins had an even better session. Ether shot past the \$3800 mark, and the third-largest crypto, Cardano, went past the \$3 price point," he added. "Investors would be pretty happy entering the weekend with decent gains."

PNB urges NCLAT to quash Jet Airways rescue plan, here's why

New Delhi: Punjab National Bank (PNB) on Thursday urged the National Company Law Appellate Tribunal to quash Jet Airways' rescue plan. The state-owned lender has alleged irregularities in the defunct debt-laden carrier's account as the reason why the rescue plan should be halted for now.

The PNB's request could delay the return of Jet Airways which was grounded two years ago. Notably, last month, a consortium of London-based Kalrock Capital and a UAE-based businessman had agreed to invest about Rs 1000 crore in Jet Airways as capital to bail out the carrier from its debt that started building up in 2019. PNB is currently arguing that the "Jet's court-appointed rescue official had initially accepted its claim of nearly 10 billion rupees (\$137 million) from the airline's backers, but then reduced it by 2 billion rupees", according to its tribunal filing quoted in a report by Reuters. PNB argued in front of the NCLAT that the reduction in the amount was arbitrary and illegal. Additional Solicitor General of India Aman Lekhi said that the tribunal has agreed to hear the case. The next date of hearing has been set for September 2021. "How PNB has been treated is wrong - both substantively and procedurally," Lekhi said. Faced with increasing competition from low-cost rivals, Jet Airways grounded all flights in April 2019 due to rising debts. Since then the carrier has been trying to make a recovery.
