**AHMEDABAD:** In Shakespeare's Julius Caesar, Mark Antony rouses people to attack Caesar's assassins saying, "Cry hawc and let slip the dogs of war." In Thaltej, as many as seven neighbours of a retired soldier allegedly began warring with him because his pet dog slipped from his grasp.

# Adani shares fall 2.5% after new report

Nine out of 10 shares of the company were down 2.5% by 12 noon after another foreign report on Adani Group came out on Thursday. The Organized Crime and Corruption Reporting Project (OCCRP) has claimed that Adani Group investors have invested millions of dollars in the market by secretly buying their own shares.

However, the group has denied the allegations. It is said that this is a conspiracy to defame and earn profit. The OCCRP claimed in its report that Adani Group companies had invested crores of rupees in the group's shares through benami investment funds in Mauritius.

Adani Group says we reject these recycling allegations. This new report appears to be an attempt to revive the illegal Hindenburg Report. Adani Group said that the allegations made by OCCRP relate to a case closed a decade ago (10 years).

At that time, the Directorate of Revenue Intelligence (DRI) investigated allegations of over-invoicing, fund transfers abroad, related party transactions and investments by PFIs. In March 2023, the Supreme Court ruled in our favor and closed the case.
