# CM replaced to 'mislead' people: Congress slams BJP over Gujarat leadership change

"Wherever there is the BJP government, there is no trace of development despite the name changing of roads and cities", Congress leader Rashid Alvi said.

New Delhi. Congress leader Rashid Alvi on Monday took a dig at BJP by criticizing the move to change leadership in Gujarat. A day after the first-time MLA, Bhupendra Patel was chosen as the new CM face of the BJP Legislative Party in Gujarat, Alvi lashed out at the party and said that the move was to "mislead" the people of the state adding that the party replaces chief ministers to "transfer blame for all their crimes". Speaking to news agency ANI, Alvi said, "It's is the character of the BJP. Wherever there is the BJP government, there is no trace of development despite the name changing of roads and cities. They believe, it is development. In the name of law and order, the states are witnessing "Jungle Raj". They transfer the blame for all their crime to



the name of the Chief Minister and takes them out. And to mislead the people of the state they introduce a new Chief Minister." "If this is the sole purpose, and I believe it is; then first the Prime Minister should resign. He has destroyed the country in 7 years. He destroyed the economy. The foreign policy is zero, unemployment is roaring like never before.

The situation has worsened, so he must resign and a new Prime Minister should be introduced. I believe Gadkari will be a great choice," he added. Alvi's statement comes in hours before Bhupendra Patel is slated to swear in the the 17th CM of Gujarat. Ex-CM Vijay Rupani was the fourth CM from a BJP-ruled state this year to resign. He joined the bandwagon of Karnataka CM BS Yediyurappa and two chief ministers in Uttarakhand--Tirath Singh Rawat and Trivendra Rawat. On this, Congress leader Tariq Anwar pinched that the fifth resignation of a chief minister in the party indicates everything is not going well in the past. "He is the fifth chief minister who has been changed despite the complete majority. It started with Assam then Karnataka, then in

Uttarakhand, two chief ministers were changed and now this is Gujarat. Yogi Adityanath is somehow spared, but it's uncertain to say when he will lose his chair. It shows everything is not going well in BJP. PM Modi and his helpers are doing this to stop the anti-incumbency," said Tariq Anwar. First-time MLA from Ghatlodia constituency, Bhupendra Patel will take oath as the 17th chief minister of Gujarat. With Assembly polls in the state scheduled to take place in 2022, BJP went with Patel, a Patidar face for the Chief Minister.

New Delhi. A day after the city faced extensive waterlogging following record

New Delhi. A day after the city faced extensive waterlogging following record rain, Chief Minister Arvind Kejriwal blamed the city's "idiosyncratic drainage system" for the flooded streets, which, he said, the AAP dispensation has inherited as a "gift" from the previous governments.

Kejriwal blames previous govts

for 'idiosyncratic drainage

system', says working on

He assured the public that they will not have to face waterlogging in the coming years in Delhi as his government is working on to overhaul the city's entire drainage system. Addressing a gathering on the occasion of inauguration of redeveloped Chandni Chowk, Kejriwal said that not only the market area but the drainage system of entire Delhi will be fixed. "We have said it earlier as well, the drainage system throughout Delhi needs to be fixed. We got this idiosyncratic drainage system as a gift from the previous governments. It needs mprove such a vast system), it was never worked upon by them (previous governments) earlier. But I can assure you after some years you won't see waterlogging anywhere in Delhi," Kejriwal said in a statement. Record heavy rains lashed the national capital on Saturday, making it the wettest monsoon season in 46 years and causing massive waterlogging that affected operations at the Delhi airport disrupted traffic on key roads and left passengers trapped in vehicles in flooded underpasses. According to the Public Works Department, over 380 waterlogging related complaints were received on Saturday. Kejriwal had last month chaired a meeting on the city's drainage plan and said that the national capital's drainage system will be improved and made "world-class" and Delhi will "get rid of waterlogging". He had said that necessary changes as suggested by Indian Institute of Technology Delhi will be made to "bolster" the city's drainage system and make it foolproof.

# Chandni Chowk's new look, new rules: A trip to the 'revamped' tourist hub

New Delhi. Delhi's busy Chandni Chowk wore a "revamped" look on Sunday as Chief Minister Arvind Kejriwal inaugurated the newly redeveloped market while also announcing new rules. Kejriwal said Chandni Chowk has become more beautiful and people come here to walk till midnight, post its redevelopment. The project was supposed to be inaugurated on April 17 this year but was cancelled due to the second Covid-19 wave.

Addressing the gathering near Fountain Chowk in the Chandni Chowk main market, Kejriwal announced that street food joints will be allowed to open for 3-4 hours till midnight so that people can come here in the night and enjoy. Lots of street food joints will be opened after closure of the market, he said. Kejriwal said earlier broken roads, dangling wires, traffic congestion were synonymous with Chandni Chowk but now it has become "beautiful" and "aesthetically appealing." In the redevelopment project, the main Chandni Chowk stretch between the Red Fort and the Fatehpuri Masjid crossing has been improved and beautified. The stretch has been developed as a "pedestrian-friendly corridor" and made aesthetically appealing with the help of red granite stone, decorative lights, plants and and street furniture among others. The stretch has been made a "no traffic zone" for motorised vehicles between 9 am and 9 pm. According to PWD officials, the project was approved in August 2018 and work on it began in December 2018. In the redevelopment project, priority has been given to pedestrian facilities as nearly 2.5 metre wide footpath has been provided for them. The redeveloped stretch has 197 electric poles and 124 CCTV cameras have been installed all over the area. Delhi Urban Development minister Satyendar Jain said the area will be given a further facelift. According to a statement issued by the Delhi government, the redeveloped Chandni Chowk has facilities like toilets, water ATMs and dustbins for pedestrians to walk without
