Dear Sir,

I, **Dinesh Kumar Deora**, Partner of M/s DM & Associates Company Secretaries LLP, appointed by the Board of Directors of **Kamat Hotels (India) Ltd** as the scrutinizer for the resolutions to be passed through Postal Ballot, Notice dated May 27, 2023. At the outset, I would like to thank you for entrusting me with the task of scrutinizer pursuant to the provisions of section 110 of the Companies Act, 2013 ('the Act') read with the Companies (Management and Administration) Rules, 2014 (including any statutory modification or reenactment thereof for the time being in force).

(1) I submit my report as under:
