SC refuses to entertain PIL for action against inflammatory speeches

NEW DELHI

The Supreme Court on Tuesday refused to entertain a PIL that sought urgent intervention against inflammatory speeches by public figures, alleging these statements endanger national unity, security and promote divisive ideologies.

Observing that there was a difference between hate speeches and wrong assertions, a bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar told the counsel for PIL petitioner 'Hindu Sena Samiti' that it was not inclined to issue notice on the petition.

"We are not inclined to entertain the present writ petition under Article 32 of the Constitution of India, which in fact refers to alleged references. Further, there is a difference between hate speech and wrong assertions. In case the petitioner has any grievance, they may raise the

Following the incident of slapping a Sub Division Magistrate by an independent candidate, there were incidents of ruckus, stone pelting and arosan in Deoli-Uniara assembly seat of Rajasthan on Wednesday late at night. The police have arrested the candidate Naresh Meena and 60 others on Thursday morning.

In Samravata village of the assembly constituency, independent candidate Naresh Meena had slapped SDM Amit Chaudhary at the polling booth during the polling on Wednesday. Voting took place at this booth until 8 at night.

After the polling, the police took Naresh Meena into custody at around 9:30 at night but as soon as Meena's supporters came to know about this, the tension escalated in the village

Meena confirmed to media that he had been picked up by the cops but then "abandoned" after his supporters' violent reaction. He even claimed to have acted heroically in saving some cops. "I did not run away... the police left me behind due to the stone-pelting. In fact, I saved some olicemen."He claimed he spent the night in the village "protected" by his supporters, who were only overcome after a heavy police force swung into action in this morning.

Centre ignored water scarcity issue in Marathwada: Congress

With Prime Minister Narendra Modi visiting Maharashtra for the Assembly election campaign, the Congress on Thursday asked what was his "vision to address water scarcity in Marath-

wada" In a message posted on "X", general secretary party Jairam Ramesh said in 2019 the then Maharashtra Chief Minister Fadnavis had promised a Rs 20,000 crore to Rs 25,000 crore package to build a water grid from Marathwada that would supply piped drinking water to every village. He said the summer this year marked five years of this promise - and it was one of the most water-scarce years that Marathwada has faced.

However, Ramesh said. "more than 600 villages and 178 hamlets in Marathwada were dependent on water tankers amidst an acute drinking water shortage. Only 19% drinking water was left in reservoirs." So, he asked, what has the BJP done to tackle water scarcity in Marathwada?
