Profit after tax for the year is Rs. 231.77 Lakhs as compared to Rs. 90.17 Lakhs in the previous year. It has improved **from 4.14 % during last year to 6.80% in current year.** Margins have improved primarily due to the reduction in the overhead and finance cost.
