एयरपोर्ट रोड में हुई चोरी की घटना का एरोड्रम पुलिस ने खुलासा किया है। पुलिस ने सूने मकान में चोरी करने वाले तीन आरोपियों को किया।

आरोपियों से चोरी किए सोने चांदी के जेवर, एक लेनोवो कंपनी का लैपटाप, नगदी रुपए जब्त किए गए हैं। पकडे गए बदमाश आदतन अपराधी है। शहर के अन्य थानों में भी इन पर केस दर्ज है। नशे की लत को परा करने के लिए बदमाश चोरी करते थे।

दरअसल, फरियादी गजेन्द्र सिंह ठाकुर पिता दुर्गा सिंह ठाकुर निवासी 287 पल्हर नगर पिछले महीने 24 मई की रात 9 बजे घर का दरवाजा अटका कर किराने का सामान लेने के लिए कालानी नगर गया था। 2 घंटे बाद किराना

सामान लेकर घर पहुंचा तो घर का सामान अस्त व्यस्त पड था। अलमारियां खुली थी। सामान चेक किया तो तीन गैस टंकी. एक लैपटाप. एक चांदी का कमरबंद. एक जोड बच्चे की पायल, एक जोड चांदी के कड़े, तीन सोने की अंगुठी नहीं थी।

अज्ञात बदमाश सामान चुरा ले गए थे। फरियादी की शिकायत पर एरोडम थाना पुलिस ने केस दर्ज किया और मामले की जांच शुरू की। पुलिस ने करीब 100-125 सीसीटीवी कैमरों के फटेज खंगाले। संदिग्ध आरोपी गोल उर्फ गौरव भालसे उम्र 22 वर्ष निवासी न्यु द्वारिकापुरी इंदौर को पकड़कर पुछताछ की। उसने अन्य साथी गौरव शर्मा, राहल गायकवाड और राकेश के साथ मिलकर सने मकान से चोरी करना स्वीकार किया। पुलिस ने अन्य आरोपी गौरव, राहुल को भी गिरफ्तार कर लिया। आरोपियों की निशानदेही पर चोरी का माल भी बरामद किया। आरोपी गोल पर पहले से 12 केस, राहल पर पहले से 4 केस और गौरव पर पहले से 13 केस दर्ज हैं। मामले में आरोपी राकेश फरार है। उसकी तलाश की

भ्रामक मामला दर्ज कराने पर जूता व्यापारी को न्यायालय द्वारा फटकार

जिला न्यायालय की ओर से नागपुर के व्यापारी को राहत, इंदौर के व्यापारी द्वारा दबाव बनाकर जबरन वसूली की साजिश

इंदौर।इंदौर के जिला एवं सत्र न्यायालय ने हाल ही में एक मामले में नागपुर (महाराष्ट्र) के एक सम्मानित व्यवसायी को राहत प्रदान की, तथा इसी मामले में झूठी रिपोर्ट दर्ज करवाकर जबरन वसूली के लिए दबाव बना रहे एक स्थानीय व्यापारी को कड़ी फटकार लगाई।

प्राप्त जानकारी के अनुसार, हुसैन नूरुल्लाह अजानी यह नागपुर के एक प्रतिष्ठित व्यापारी हैं तथा वहां द मॉन्टीना शूज नाम से इनके 3 बड़े प्रतिष्ठान हैं. कुछ समय पहले एक संपर्क के माध्यम से वे इंदौर स्थित चॉइस कलेक्शन (एम जी रोड) के मालिक सुरेश केशवानी के संपर्क में आए. केशवानी ने अजानी को होलसेल में जूते-चप्पल बेचने का प्रस्ताव दिया. अजानी ने स्वीकार करते हुए माल मंगवाया और करार के अनुसार किश्तों में पेमेंट भिजवाने लगे. अजानी द्वारा डील के आधार पर नियमित रूप से पेमेंट किए जाने के बावजूद केशवनी के छोटे भाई, राजेश केशवानी अचानक इस पूरे घटनाक्रम के बीच आए और अजानी पर एकमुश्त पैसा देने का दबाव बनाने लगे. अजानी ने उन्हें बारंबार डील की शर्तें याद दिलाईं पर केशवानी अड़े रहे. अजानी पर



दबाव बनाने के लिए राजेश ने सेंट्रल कोतवाली थाने में मनगढंत आरोप लगाते हुए दफा 420 (धोखाधडी) और 409 (अमानत में खयानत) के अंतर्गत एफआईआर डाल दी. साथ ही विभिन्न समाचारपत्रों में हुसैन अजानी के खिलाफ गलत बातें छपवाईं और उसे वायरल कर दिया. इससे अजानी की सामाजिक प्रतिष्ठा को गहरा नुकसान पहुंचा और दशकों से चले आ रहे उनके प्रतिष्ठान का नाम खराब

अजानी को जब यह बात पता चली तो उन्होंने कानूनन इसका मुकाबला करने का फैसला किया और अपने अधिवक्ता के माध्यम से अपनी बात पुख्ता सबूतों के साथ माननीय सत्र न्यायालय के समक्ष रखी. रिपोर्ट में धारा 409 का समावेश होने के कारण अजानी ने अग्रिम जमानत की अर्जी लगाई और मा. न्यायालय को संतोषपूर्ण दस्तावेज मिलने पर उन्हें जमानत दी गई. साथ ही मा. न्यायालय ने कई बिंदुओं पर समुचित साक्ष्य और समर्थक दस्तावेज के अभाव में राजेश केशवानी को कड़ी फटकार लगाई. (जमानत की प्रति संलग्न है) मा. न्यायालय के आदेशपत्र के मुख्य अंश हैं:

1. अजानी को नागपुर स्थित साफ-सुथरी छवि वाला प्रतिष्ठित व्यवसायी बताया गया है जिनका कोई गलत रिकॉर्ड नहीं है.

2. फौजदारी के साधारण मामले को आपराधिक मुकदमा बनाकर बेवजह किसी पर दबाव बनाने को अनैतिक मानते हुए माननीय न्यायालय ने केशवानी की भर्त्सना की है.

3. माननीय न्यायालय ने उल्लेखित किया है कि नियत एवं छल तत्व साबित नहीं होते, बल्कि एफआईआर में अप्रासंगिक तथा अपमानजनक धाराएं लगाई गई हैं.

साक्ष्यों की कमी पाई गई है, जिससे यह साबित होता है कि एफआईआर का मूल उद्देश्य केवल हुसैन अजानी को प्रताड़ित करना था, न कि विवाद सुलझाना.

पुलिस की मिलीभगत का भी उल्लेख है. याचिका में कहा गया है कि यदि

अजानी की जमानत मंजूर कर दी गई तो वे विवेचना में सहयोग नहीं करेंगे, जिसे मा. न्यायालय ने अजानी की स्थानीय साख और ट्रैक रिकॉर्ड के आधार पर खारिज कर दिया. 21 मई 2024 को हुई हालिया सुनवाई में अजानी को तीन माह का समय दिया गया है ताकि वे राजेश केशवानी द्वारा तोड़-मरोड़कर दिए गए तथ्यों पर अपना पक्ष प्रस्तुत कर सकें. अजानी ने माननीय न्यायालय और न्याय व्यवस्था के प्रति अपना आभार व्यक्त किया. इस केस में हुसैन अजानी की ओर से अधिवक्ता श्री गगन बजड़ ने पैरवी की.
