Sub: Allotment of Shares under Company Employee Stock Option Schemes

The Allotment Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 48,099 equity shares of Rs.10/- each, being the exercise of 2,405 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 18,299 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 27,395 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022).

Consequent to this the paid-up equity share capital has increased from 3,53,55,172 equity shares of Rs.10/- each to 3,54,03,271 equity shares of Rs.10/- each. - ii) The National Stock Exchange of India Limited vide their letter No.NSE/LIST/252668-7 dated 13th October, 2014 for ESOS 2013, letter No.NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
