Central Electricity Authority, Ministry of Power, vide letter dated July 7, 2023, *inter-alia* communicated the approval/recommendation of 14th NCT, wherein RECPDCL has been appointed to act as Bid process Coordinator (BPC) for the purpose of selection of Bidder as Transmission Service Provider (TSP) for transmission projects at Western Region Network Expansion scheme in Kallam area of Maharashtra.

In view of the above, KTL has been incorporated. After selection of the successful bidder in accordance with the TBCB guidelines, said company would be transferred to the successful bidder along with all assets & liabilities.
