Mishtann Foods Ltd. (BSE: 539594) is pleased to announce their Audited Financial results for quarter and year ending 31 March 2022. In the board meeting held on 18 April, 2022, the company considered, adopted and approved financial results for the quarter and yearended 31 March 2022.

For the quarter ended 31 March 2022, the revenue from operations grew 45% YoY, from Rs. 105.81 crore (Q4FY21) to Rs. 153.47 crore (Q4FY22). Net Profit increased 4100% times YoY from Rs. 0.31 crore to Rs. 13.15 crore. EBITDA stands at Rs. 22.33 Cr (Q4FY22), up 1107.03% from Rs. 1.85 crore (Q4FY21).

For the year ended 31 March 2022, the revenue from operations rose 42% YoY, from Rs. 351.07 Cr (FY21) to Rs. 498.57 Cr (FY22). PAT increased 4200% YoY from Rs. 0.73 Cr (FY21) to Rs. 31.21 Cr (FY22).

The board further recommended bonus equity shares in the proportion of 1 (One) Equity Share of Re. 1/each for every 1 (one) Equity Share of Re.1/- each held by shareholders of the Companyas on the record date, subject to the approval of members and other approvals, consents, permissions, conditions and sanctions.
