Former US commander who killed Osama arrested Charged with drunken assault; On the same day bail was obtained on a bond of 2 lakhs



Former US Navy SEAL commander Robert J O'Neill, who infiltrated Pakistan's Abbottabad and killed terrorist Osama bin Laden, has been arrested in the Texas city. Neil was charged with drunken assault and indecent exposure. However, the jail records only mention beatings. As reported by the New York Post, Neil was released on a bond of \$2 lakh 88 thousand just a few hours after his arrest.

supports his claim. On September 11, 2001, there was a terrorist attack on America, the most powerful country in the world. Terrorists attacked New York's World Trade Center with an airplane, killing three thousand people, and a terrorist organization called Al Qaeda claimed responsibility. It is counted among the worst terrorist attacks in the world. His mastermind was Osama bin Laden. American security agencies started looking for him.

In July 2010, US security agencies began monitoring a Pakistani man. His movements were confined to bin Laden's house, which was also confirmed by an American satellite. These satellites have been monitoring bin Laden's house 24 hours a day for years. Due to the structure of the house, long-high walls, balcony walls, etc., his suspicions became darker. President Obama agreed to move forward with a third plan. After several days of planning and several

meetings, the CIA set a date of May 2, 2011 to kill Osama. 2 American helicopters from Afghanistan arrived at Bin Laden's home in Abbottabad, when one of the helicopters crashed. The CIA deployed two Chinook helicopters on the border with Afghanistan. It was planned that he would be called in case of any untoward incident. He was also informed. Here, bin Laden was trapped in his own house. He also built a wall outside the balcony of his house for security. The doors of the rooms were iron and the windows were low. So it was not even possible to see what was happening outside.

When the commander entered bin Laden's house, two of bin Laden's wives were also present inside the room. Among them, his fifth wife, Amal al-Fattah, preceded bin Laden herself. According to Peter Bergen, who wrote a book

on bin Laden's operations, bin Laden's bedroom shelf contained several AK-47s and Makarov machine pistols. Terrified bin Laden could not even lift the pistol. Even Bin Laden did not object when his wife came forward herself. The jawans first fired at his wife's ankle and she fell there. Osama bin Laden standing in front was unarmed. He was wearing a salwar kameez and on his head was a hat worn during namaz. A 5.56mm bullet was shot in his chest by a man standing in front. As he fell backwards, another bullet was fired into his head by Jawa. The bullet hit him above his left eye. And the soldier said - Geronimo, Geronimo, Geronimo.

Several codes were created during the launch of this mission. One of those codes was Geronimo. That meant Bin Laden had been found. Suddenly, the CIA team at the White House hears Geronimo on the action feed. Then came a voice again "Geronimo E.K.I.A." meaning "killed in enemy action."

I believe in Hinduism. I inherited this from my family. America was founded on Judeo-Christian values. Like Hinduism, Judeo-Christianity has teachings such as renunciation, selfless karma and ritualism. According to Hinduism, God is within you and according to Christianity, you are created by God in His own image.

As a Hindu, I can better protect other people's rights to religious freedom than other politicians. My aim is to preserve the values of family, faith and patriotism in American society. American society is losing these values.

The real problem in America is not between different religions but between those who believe in traditional religion and those who believe in

secularism. In the form of secularism, there are people today who believe in Wokjin (liberalism), globalism, transgenderism and even covidism.

In America this problem arises when people who believe in these various religions and ideologies in the name of secularism adopt them as religions and then

refuse to accept the existence of other traditional and established religions.

Question 2. What is your opinion and assessment of Prime Minister Narendra Modi?

Narendra Modi is a great Prime Minister. He has adopted a free market economy to eradicate poverty in India. America has also been successful in achieving prosperity in this way. America can learn from Modi how a leader keeps his national identity paramount. In America today, we need a president who can proudly represent his national identity. US President Biden has failed to do so.

Question 3. How do you see Modi's role in the rapidly changing world of others?

We have to prevent China from attacking Taiwan. America needs India's support. We will work on a common strategy with India to deter Chinese ships from

Wagner Chief said - a plane will crash In an interview 4 months before his death, he said- Russia is heading towards destruction

Moscow After the death of Russian rebel chief Prigozhin, an interview with him is going viral. In this he is talking about the plane crashing during the flight. Prigozhin also says that he would rather die than lie to Russia. On April 29, he was interviewed by Russian blogger Semyon Pegov.

In one of his clips, Prigozhin says - Russia is on the verge of destruction. This is because the people who speak the truth and are not ready to collude with senior officers are being thrown out of the defense sector.

Prigozhin further says - Why am I speaking so truthfully today? It is because I am not above the people living in this country. Today they are being lied to. I'd rather be killed.

Prigozhin said during the interview - I will not lie. Today Russia is headed for destruction. If the system is not changed, a plane will crash one day soon. The video was shared on Wagner Group's Telegram channel War Zone. This clip

of about 40 seconds of Prigozhin's interview has been commented on by many people.

One user said- Prigozhin already knew about the plane crash. Some users also speculated that Wagner Chief might be alive and would appear soon. Then he will surely take his revenge. The head of the Russian Air Force, Sergei Surovkin, was removed from his post the same day Prigozhin's plane crashed. In such a situation, users are also saying that Prigozhin is alive and Surovkin is with him.

On the other hand, after the death of Chief Wagner, President Putin has asked the soldiers of the private army to swear loyalty to Russia and the government. Putin signed the deal with immediate effect on Friday. Under this everyone working for Russia or their military must be loyal to Russia.

It aims to strengthen the government's grip on groups like Wagner. On Wednesday, August 23, the plane in which the

Wagner Chief was traveling crashed. According to Russia's Aviation Ministry, Prigozhin's name was on the passenger list and was on board the ship. He was the chief of the private army Wagner Group. 10 people died in this incident.

The plane was traveling from Moscow to St. Petersburg. In addition to Prigozhin, private army co-founder and former Russian special forces commander Dmitry Utkin was also aboard the plane. Other Wagner officers were also present on the plane.

On June 23, the Wagner group announced a rebellion against Russia. Wagner's army left the Ukrainian camp and entered the Russian border. He captured the city of Rostov and the military headquarters. Then Prigozhin said - we are not afraid of death. He claimed that Wagner's troops shot down several Russian army helicopters. According to Reuters, Prigozhin asked to come to Rostov to meet the Russian Defense Minister.

Florida Mass Shooting, 3 Blacks Dead Attacker Shoots Himself; Police said- the accused had hatred with blacks

There was a shooting in a store in Jacksonville, Florida, USA on Saturday. Officers said a man entered the store with a gun. He targeted and shot three black men. All three died. According to Reuters, after killing the three, the accused also shot himself.

Jacksonville Police Officer TK Waters said - the accused hated black people. It was a racial attack. The deceased include 2 men and 1 woman. Prior to the shooting, the accused had also released several manifestos to family members, the media and police officers, in which he expressed hatred against

blacks. The FBI said that hate crimes have always been their priority. This is done with the intention of intimidating the people of particular community. Current US President Joe Biden and Attorney General Merrick Garland have been informed about the shooting in Florida. Also, people living in Jacksonville, especially black people, have been put on high alert.

According to America's Gun Violence Archive, mass shootings are on the rise here. 469 such cases have been reported so far this year. The history of gun culture in America is about 230 years old.

Pakistani doctor jailed for 18 years in US

A Pakistani doctor has been sentenced to 18 years in prison in America. A district court convicted him last year of plotting to attack the US. After this he has been sentenced on Friday. According to news agency Reuters, 31-year-old Masood Masood was helped to help ISIS to carry out attacks in America. He tried to go to Syria via Jordan in 2020.

After failing in this attempt, he tried to fly from Minneapolis to Los Angeles where Masood was supposed to meet someone who would help him reach Syria by cargo ship. Masood was arrested by the FBI just before he caught a flight to Minneapolis.

The public prosecutor said that Masood came to America on a work visa. Some detectives are hired to provide information on suspects in America. In front of him, Masood had given information about joining ISIS from January 2020 itself.

Masood said he thought these people were affiliated with ISIS. He pledged full support to the terrorist organization and its leader. Masood told spies that he wanted to carry out a 'lone wolf' attack in America. A 'lone wolf' attack is when a person attacks alone and tries to kill more people, it is called a 'lone wolf' attack.

Masood's information was obtained from social media platforms

A young man of Indian origin killed his girlfriend

A person of Indian origin has been arrested in California, USA. The man is accused of shooting and killing a woman in a mall parking garage. According to a report by California news outlet 'KCR.com', the 29-year-old man was dating the woman.

The incident took place in Roseville, California. Police said Simranjit Singh arrived at the mall with his girlfriend on Saturday morning (local time) and then shot the woman on the third floor of the parking garage. After committing the crime, Simranjit fled from the spot and fled leaving the gun in the garage.

Roseville Police Department Lt. Chris Campa said the two got into an argument at the mall. The police caught Singh near a store on the way to the mall. Police said he bought the shirt from the store to hide his identity. He put on his new

shirt, and put the old shirt in the bag. He wanted to leave the shop quickly and run away.

However, the area was locked down as soon as the shooter was reported. Clampa said several officers were dispatched to find the suspect based on eyewitness reports and the direction he fled.

The police also questioned the eyewitnesses and examined the CCTV footage of the gallery. After this Singh was arrested. He has been charged with murder and booked into the Placer County Jail.

In a separate case, an Indian-origin youth in the UK has been charged with stabbing two people to death in West London. The incident took place during a community event in Southall. The name of this person is being told as Gurpreet Singh.

An eyewitness, Rajveer Singh (name changed), told The Australia Today that five Khalistani goons started abusing Indians and Hindus.

Gurpreet Singh, 25, appeared at Uxbridge Magistrates' Court in London on Friday. Masood had given custody to appear at Ilesworth Crown Court in London on September 14.
