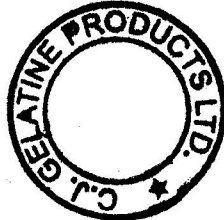

We may have Covid vax for children by Sept: ICMR-NIV

AGENCIES / New Delhi
Novovax and another interesting one by an intranasal vaccine by Bharat Biotech, which doesn't require a jab and can be delivered through nostrils," Abraham added.
Earlier in an interview with ANI, Dr Randeep Guleria, Director of AIIMS, on the Covid vaccines for children had said, "Vaccines for children in India should come out now because trials are already underway for vaccines available in the country. Bharat Biotech's trials are in the final phase, and by September, we will have the data." Talking about how effective the Covid vaccine is on the Delta Plus variant, Dr Priya Abraham said, "Delta Plus variant is less likely to spread than the Delta variant, which is present in over 130 countries. In NIV, we have studied antibodies produced in vaccinated people and have checked them against this variant. The efficacy of antibodies against Delta reduces two-three folds. Yet, the vaccines are protective against the variants."

Coronavirus vaccine for children might be available for use in September or October this year, Dr Priya Abraham, Director of Pune's (Indian Council of Medical Research) ICMR-National Institute of Virology (NIV), informed.
In an interview with an OTT channel of the Department of Science and Technology, Abraham said, "Phase 2 and 3 trials of Covaxin are underway for children between 2-18 years. Hopefully, the results will be available soon, which will then be presented to the regulators. So, by September or just after it, we may have Covid vaccines for children." Further, she informed that apart from Covaxin, Zyudis Cadila's vaccine trial for children is also underway. "Zyudis Cadila's vaccine will be the first DNA vaccine available for use."
Besides, there is Genovva Biopharmaceuticals Ltd's m-RNA, Biological -E vaccine, Serum Institute's

India conducts 50-cr plus tests

OUR BUREAU / New Delhi
India on Thursday crossed the landmark of over 50 crore people tested so far for coronavirus, 18.74 lakh of them in the past 24 hours. New cases reported during the day dropped to 35,178. The nationwide deaths jumped to 530 as against 440 on Wednesday while the active cases further dropped to 3,64 lakh. Kerala reported the highest infections at 21,727 and deaths of 179. The total tally of the Covid cases in India has reached 32.29 million, though 31.56 million of them have recovered while 4.33 lakh died. The daily recovery at 39,157 were also higher than the day's infections. The daily positivity rate was 1.94 per cent. As many as 56.36 lakh Covid-19 doses were administered in the past 24 hours, raising the total vaccination to 56.65 crore.

'Over 3.86 cr people didn't get 2nd dose in stipulated time'

Over 3.86 crore people did not get their second dose of anti-Covid vaccines within the stipulated period of time, the government has said in response to an RTI query.
Activist Raman Sharma had filed a Right to Information (RTI) Act query seeking to know how many people did not take second dose in the stipulated time period.
The Covid Vaccine Administration Cell of Union Health Ministry replied, "Number of beneficiaries who got first dose of Covishield but did not get second dose within stipulated period of time is 3,40,72,993 while those who got first dose of Covaxin but did not get their second is 46,78,406 (data as on 17th August 2021).
It further said the total number of beneficiaries who got their first dose of Covaxin but did not get their second within the stipulated period of time as prescribed by the government as per the due report of in Co-WIN portal is 46,78,406 (data as on 17th August 2021).

Will close schools if cases rise: UP govt

Uttar Pradesh government, which has decided to open schools for physical classes, on Thursday said the attendance for students will not be compulsory and schools may be closed again if the Covid situation worsens.
Deputy CM Dinesh Sharma told this to the state legislative council while replying to a question by teacher constituency member Dhruv Kumar Tripathi.
"In basic education, attendance is not compulsory. We have also not made attendance mandatory for classes from 9 to 12," Sharma said.
"Guardians, teachers and political organisations have also said the offline education should be started even if it is for a shorter period," he said. "In UP the present atmosphere is sufficiently secure but if there is any indication of any concern (regarding Covid), we can also close schools," he added.
