YOGA prez underscores importance of yoga

THE HOLISTIC APPROACH to health, well-being provided by the practice of yoga is critical now as the COVID-19 pandemic has disrupted lives, created loneliness and has led to increased anxiety, UN General Assembly President has said during the virtual commemoration of the 6th International Day of Yoga.

It has disrupted lives, created loneliness caused by social distancing as it has also led to increased anxiety caused by economic difficulties, fear of illness and worry about loved ones. This is only natural. This year's celebration comes amidst this 'critical context', UNGA President Tijiani Muhammad-Bande said in a virtual message. In commemorating the International Day of Yoga, he stressed the importance of practicing yoga and its potential in helping people deal with increased anxiety due to the disruptions caused by the pandemic. 'In previous years, India's Permanent Mission commemorated the day at a grand scale in the UN premises. However, this time the mission hosted a virtual 'Yoga for Health' - 'Yoga at Home' session to mark the International Day of Yoga at a time when the global outbreak of COVID-19 has upended lives and disrupted lifestyles of people across the world, India's Permanent Representative to the UN Ambassador T S Tirumurti said the global outbreak of COVID-19 has upended lives and disrupted lifestyles of people across the world.

WITH THE SHADOW of the COVID-19 pandemic looming large, International Day of Yoga will be celebrated on digital media platforms mass gatherings as Prime Minister Narendra Modi message would be the highlight of the occasion. Yoga Day will go digital for the first time since June 21, 2015, when it began to be celebrated annually across the world, coinciding with the Summer Solstice each year.

This year's theme 'Yoga at Home and Yoga with Family' and people will be able to join the celebrations virtually at 7 am on June 21. The Indian mission abroad is trying to reach out to the people through digital media as well as through the network of institutions which support yoga officials, said. The Ministry of AYUSH had planned to hold a grand event in 12 but cancelled it due to the pandemic. On December 11, 2014, the United Nations General Assembly declared June 21 as 'International Day of Yoga', months after Modi had proposed the idea.
