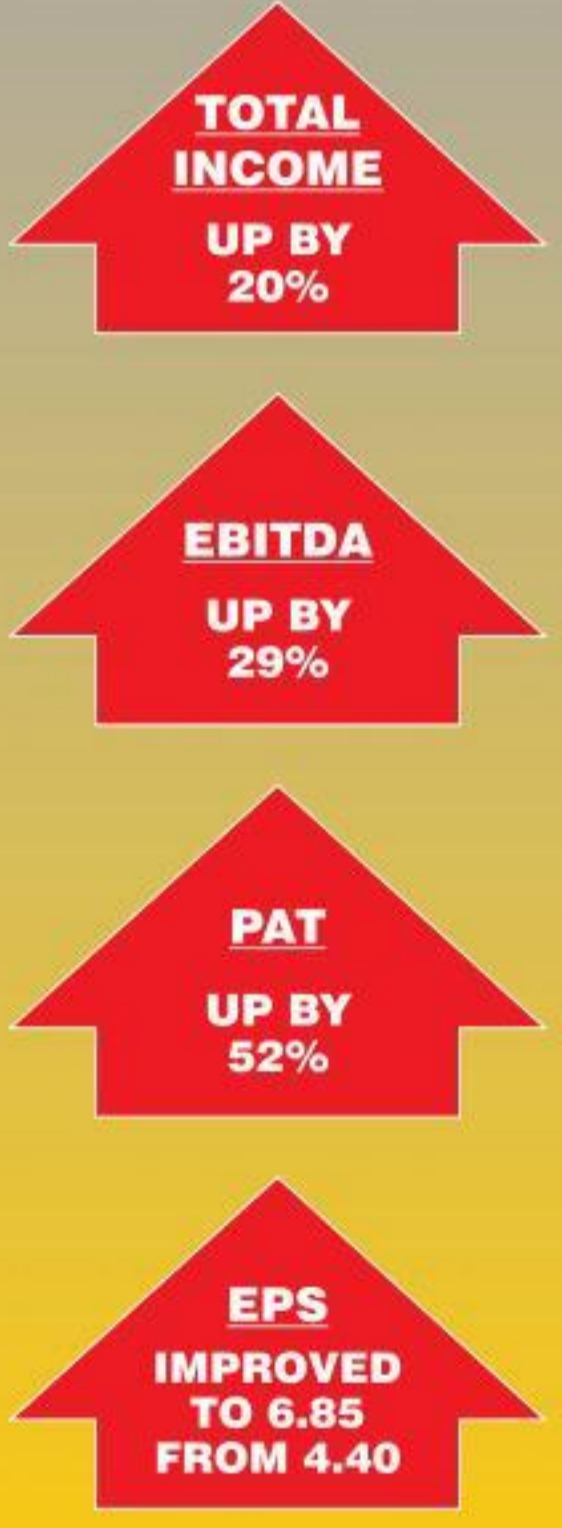

Based on the victim's complaint, we arrested eight women and a man and apprehended three boys. We have now arrested four more women. They are all related and live in the same locality," said DCP (Shahdara) R Sathiyasundaram.

The Commission said it is looking for an immediate plan to protect the survivor and her family as the accused have a criminal background. On Wednesday, the DCW issued a statement: "The Delhi Police is yet to provide the DCW with details of measures being taken for protection of the survivor and her family. पंचकुला: हरियाणा में कोरोना संक्रमितों की मौत का सिलसिला लगातार जारी है। एक दिन में प्रदेश में जहां 17 लोगों ने कोरोना संक्रमण से दम तोड़ा वहीं, 3,267 लोग संक्रमण की चपेट में आए हैं। प्रदेश में आज कोरोना के ओमीक्रोन स्वरूप के 336 मामलों की पुष्टि भी हुई है। अब तक राज्य में 10,337 लोग अपनी जान गंवा चुके हैं जबकि कुल 20,859 सक्रिय मामले हो गए हैं। प्रदेश सरकार के स्वास्थ्य विभाग की ओर से जारी बुलेटिन के मुताबिक बुधवार को प्रदेश में हुई मौतों में से सबसे अधिक चार मौतें गुरुग्राम में दर्ज की गई हैं। वहीं, हिसार- करनाल- यमुनानगर- महेंद्रगढ़-फतेहाबाद में 2-2 जबकि फरीदाबाद-भिवानी-झज्जर में एक-एक कोरोना संक्रमितों की जान गई है।

# हरियाणा में स्कूल खोलने की मांग को लेकर बच्चे, परिजन सड़कों पर उतरे

चंडीगढ़, 2 फरवरी (जनसत्ता)।

हरियाणा में स्कूल खोले जाने की मांग अब तेज हो गई है और अचानक इस मांग के समर्थन में प्रदर्शन भी शुरू कर दिए गए हैं। कोविड संक्रमण के चलते अब तक केवल 10वीं-12वीं के लिए ही स्कूल खोले गए थे लेकिन अब ग्रामीण छोटी कक्षाओं के लिए भी स्कूल खोल दिए जाने की मांग उठाने लगे हैं।

शिक्षा विभाग के एक आला अधिकारी ने इस बात की पुष्टि करते हुए जानकारी दी कि हरियाणा में जिला फतेहाबाद के गांव धानी संचेला और भुथन कलां नामक दो गांवों में अपने बच्चों को लेकर ग्रामीण वहां आज बुधवार सरकारी स्कूलों में जा पहुंचे और तत्काल प्रभाव से स्कूल खोलने की दुहाई देने लगे और जब वहां उपस्थित शिक्षकों ने सरकारी दिशा-निर्देशों का हवाला देते हुए छोटे बच्चों की कक्षाएं खोलने से इनकार किया तो वहां पहुंचे-लिखे नौजवानों ने ही कक्षाएं लगानी शुरू कर दी।

इन ग्रामीणों में धानी संचेला गांव की महिलाओं ने तो रोषस्वरूप वहां हरियाणा सरकार में शिक्षामंत्री कंवर पाल गुज्जर का पुतला भी फंका। स्कूल खोलने की अपनी मांग दोहराते हुए उन्होंने मौके पर नारे लगाए - 'बच्चा-बच्चा करे पुकार, स्कूल खोल दे खट्टर सरकार' और 'कोरोना एक बहाना है शिक्षा को मिटाना है।'

ग्रामीणों का कहना है कि वह स्कूल खुलवाने की अपनी मांग के साथ बीते 8 दिनों से धरना दिए बैठे हैं। ग्रामीण सतबीर सिंह का कहना है, 'गांव के युवाओं ने छोटे बच्चों की कक्षाएं लेनी की जिम्मेदारी उठाई है। अब हमारा यह धरना आगे भी जारी रहेगा, जब तक प्रदेश सरकार सभी कक्षाओं के लिए स्कूल नहीं खोल देती।' शिक्षा विभाग में एक आला अधिकारी का कहना है कि ऐसी ही मांग जिला फतेहाबाद में गांव मोचीवाली, बैजलपुर और दीवाना के अलावा जिला हिसार के गांव बिटमाड़ा और कलीरमन में भी उठने लगी है।

# अमरिंदर के जाते ही मुख्यमंत्री पद के लिए 42 विधायकों ने मुझे बताया था अपनी पसंद, चन्नी को मिले थे दो वोट: जाखड़

लुधियाना, 2 फरवरी (जनसत्ता)।

पंजाब कांग्रेस के पूर्व प्रधान सुनील जाखड़ ने मुख्यमंत्री पद को लेकर बड़ा दावा किया है। उन्होंने कहा कि पिछले साल सितंबर में केप्टन अमरिंदर सिंह को हटाने के बाद कांग्रेस ने नए मुख्यमंत्री के लिए मतदान करवाया था। इसमें 79 विधायकों में से 42 विधायकों ने उनके नाम पर वोट किया था। इसके बाद सुखविंदर सिंह रंधावा को 16 पंजीत कौर (अमरिंदर सिंह की पत्नी) 12, नवजोत सिंह सिद्ध को 6 और चरणजीत सिंह चन्नी को सिर्फ 2 वोट मिले थे। इसके बावजूद वह सीएम बन गए।

सुनील जाखड़ ने फाजिल्का जिले के आबोहर हलके के गांव मौजगढ़ में पार्टी कार्यकर्ताओं को

संबोधित करते हुए यह बात कही। उन्होंने कहा, 'भगवान वही करता है जो सही होता है, मुझे किसी चीज का कोई अफसोस नहीं है पर मैं आपको यह असलियत बता रहा हूँ।'

जाखड़ का यह वीडियो सोशल मीडिया पर खूब वायरल हो रहा है। वीडियो में जब यह कहते हैं कि चन्नी को सिर्फ 2 वोट मिले थे तो पीछे से खूब हंसने की आवाजें आती हैं। वीडियो में जाखड़ यह भी कहते हैं उस समय राहुल गांधी ने मुझे बुलाया था और पूछा था कि मैं पंजाब का उप मुख्यमंत्री बनने के प्रति गंभीर क्यों नहीं हूँ। मैंने उन्हें बताया कि मेरे लिए यही बहुत बड़ी बात है कि लोगों ने मुख्यमंत्री पद के लिए सर्वाधिक वोट मुझे ही दिए। मुझे इससे ज्यादा कुछ नहीं चाहिए।

वैसे भी मैं उस समय कुछ भी नहीं था, विधायक भी नहीं था।

गौरतलब है कि पंजाब में अभी तक मुख्यमंत्री की दौड़ में जाखड़ का कहीं नाम तक नहीं है। ऐसे में एक सर्वाजनिक बैठक में उनका यह दावा करना कांग्रेस के लिए मुश्किल पैदा कर सकता है। पार्टी ने पहले से ही भितरघात चल रहे हैं। ऐसे समय में इस तरह के बयान से पार्टी में एकजुटता की कमी साफ दिखाई देती है।

जाखड़ ने अपने भाषण में यह भी कहा, 'मारण वाले ने ता कसर नहीं छोड़ी सी पर मुझे जीवन में इसपर कोई अफसोस नहीं रहा।' जाखड़ अबोहर से चुनाव लड़ रहे अपने भतीजे संदीप जाखड़ के पक्ष में प्रचार कर रहे हैं।

## दिल्ली : कोरोना के 3,028 मामले, 27 मौत

नई दिल्ली, 2 फरवरी।

दिल्ली स्वास्थ्य विभाग की ओर से बुधवार को जारी रिपोर्ट में कोरोना के मामलों में गिरावट देखी गई। बुधवार को कुल 3,028 नए मामले सामने आए। जबकि 27 मरीजों की मौत हुई। इस दौरान संक्रमण दर 4.73 फीसद रही। दिल्ली में बुधवार को 63982 लोगों की कोरोना जांच की गई। हालांकि मंगलवार की तुलना में नए मामलों की संख्या बुधवार को कम रही। दिल्ली सरकार की रपट के अनुसार

1331 मरीज अस्पतालों में भर्ती हैं। इनमें से 451 मरीज आक्सीजन के सहारे हैं, जिनमें से 99 मरीज वेंटिलेटर पर हैं। 1037 मरीज घरों में एकांतवास में हैं। वहीं बीते दिन हुई मौत के मामलों को मिलाकर दिल्ली में कुल 25,919 मरीजों की अब तक मौत हो चुकी है।

वहीं राजधानी में अब तक कुल 18,35,979 मरीज संक्रमण की चपेट में आए हैं। इसमें से 17,95,190 मरीज महामारी से उबर चुके हैं। बुधवार को निषिद्ध क्षेत्रों की संख्या 35,961 दर्ज की गई। वहीं 790 लोगों ने हेल्पलाइन पर काल कर मदद मांगी और 1,542 काल एंबुलेंस के लिए किए गए।

## उपराज्यपाल ने शुक्रवार को बुलाई डीडीएमए की बैठक

कोरोना संक्रमण के मामलों में कमी आने के बाद अब दिल्ली में और अधिक राहत के लिए मांग उठनी शुरू हो गई है। दिल्ली के जिम व फिटनेस केंद्र के मालिकों के साथ कारोबारी भी बाजारों में रात्रि कर्फ्यू खत्म किए जाने की मांग कर रहे हैं। दिल्ली के उपराज्यपाल ने शुक्रवार को दिल्ली आपदा प्रबंधन प्राधिकरण (डीडीएमए) की बैठक बुलाई है। इस बैठक में मुख्यमंत्री समेत संबंधित विभागों के अधिकारी शामिल रहेंगे।

कोरोना संक्रमण के मामलों में लगातार आई गिरावट के बाद दिल्ली सरकार लगातार राहत दे रही है। इसी के तहत बाजारों में सम-विषम व्यवस्था और हर सप्ताह होने वाले कर्फ्यू से भी राहत दी गई थी। जानकारी के मुताबिक इस बार कोशिश यह भी की जा रही है कि दिल्ली सरकार द्वारा चल रहे तकनीकी शिक्षण संस्थानों को भी खोला जाए। माना जा रहा है कि इसकी मदद से बच्चों के लिए तकनीकी शिक्षण की गतिविधियां शुरू हो सकेंगी। उधर दिल्ली के बाजार संघों ने सरकार ने रात्रिकालीन कर्फ्यू हटाने या फिर समय बढ़ाए जाने की अपील की है।

## मौसम विभाग ने आज जताई बारिश की संभावना

दिल्ली में बुधवार की सुबह हल्के कोहरे के साथ हुई। भारतीय मौसम विज्ञान विभाग (आइएमडी) ने जानकारी दी कि इस दौरान न्यूनतम तापमान 11.2 डिग्री सेल्सियस दर्ज किया गया जो कि मौसम के औसत तापमान से तीन डिग्री अधिक है। जबकि अधिकतम तापमान औसत से एक डिग्री कम 23.4 डिग्री दर्ज किया गया। दिन भर सूरज व बादलों के बीच आंख-मिचौली का खेल जारी रहा। मौसम विभाग ने गुरुवार से बारिश के आसार जताए हैं। उसके बाद ठंड फिर बढ़ सकती है। आइएमडी ने कहा कि सुबह साफदरजंग वेधशाला में कोहरे के कारण दृश्यता घटकर 400 मीटर, वहीं पालम वेधशाला में दृश्यता

500 मीटर दर्ज की गई, जो दिन में धूप खिलने के बाद बेहतर हुई।

वहीं दिल्ली में बुधवार को वायु गुणवत्ता बेहद खराब श्रेणी में रही। वायु गुणवत्ता सूचकांक (एक्यूआइ) 341 था। मौसम विज्ञानियों ने दिन में हल्का कोहरा छाए रहने और अधिकतम तापमान के 21 डिग्री के आसपास रहने का अनुमान जताया था।
