Subject: Scrutinizer's Report on Postal Ballot Results (e-voting) conducted in terms of the provisions of Section108 &110 of the Companies Act, 2013('the Act'), Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 ('the Rules') and other applicable provisions of the Act and Rules made thereunder (including any statutory modification or re-enactment thereof for the time being in force).

Sir,

I, Hemant Kumar Singh, Partner of Hemant Singh & Associates, Practicing Company Secretaries, was appointed by the Board of Directors of MAHANAGAR TELEPHONE NIGAM LIMITED ("the Company")as Scrutinizer for the purpose of scrutinizing postal ballot voting process, conducted only by way of remote e-voting (hereinafter referred to as 'e-voting') in fair and transparent manner for passing one (1) ordinary resolutions, as set out in the Postal Ballot Notice dated July 18, 2022 and as sent to the members of the Company via email, in terms of inter-alia General Circular no. 14/2020 dated April 8, 2020, General Circular no. 17/2020 dated April 13, 2020 read with other relevant circulars, General Circular no. 20/2021 dated December 8, 2021 and General Circular no. 03/2022 dated May 5, 2022 issued by the Ministry of Corporate Affairs, Government of India in the backdrop of Covid-19 pandemic (collectively referred to as "MCA Circulars"). We hereby submit our report as under:

- 1. The Company has informed us that, the Company completed the dispatch of the Postal Ballot Notice dated July 18, 2022 by email on July 26, 2022 to the Members whose email IDs were registered with the Company / Registrar & Share Transfer Agent / Depository / Depository Participants and whose names appeared in the Register of Members/List of Beneficial Owners as on Friday, July 22, 2022 (cut-off date) received from the Depositories/ Registrar and Share Transfer Agents.
- 2. The Company had appointed Central Depository Services Limited (CSDL), for the purpose of providing e-voting facility to all its members, as the Authorized Agency.
- 3. The Company published an advertisement regarding completion of dispatch of Postal Ballot Notice in newspapers viz. Financial Express all edition(English)&Jansatta Delhi edition(Hindi Newspaper) on July 27, 2022.
- 4. Particulars of Postal Ballot votes (e-voting) received from the members have been entered in the Register maintained separately for the purpose.

- 5. The list of members who had cast their votes, their holding details and details of vote cast on the resolutions, based on the reports generated by Central Depository Services Limited ("CDSL"), (agency for providing the remote e-voting platform), are kept in our safe custody.
- 6. Members holding shares of the Company as on Friday, July 22, 2022, ("the cut-off date"), were entitled to vote on the one (1) ordinary resolutions as set out in the Postal Ballot Notice dated July 18, 2022.
- 7. The e-voting facility was kept open from Friday, July 29, 2022 (9.00 am) till Saturday, August 27, 2022 (5.00 pm), both days inclusive.
- 8. All votes on the resolutions set out in the notice of postal ballot dated July 18, 2022, cast through e-voting platform (www.evotingindia.com) upto (5.00 pm) on August 27, 2022, were unblocked on August 27, 2022 after 5.00 pm in the presence of two witnesses, who are not in the employment of the Company. The details containing the list of Members who voted "for" or "against" the resolution(s) was downloaded from the e-voting portal of CDSL and same was considered for our scrutiny.
