The Ministry of Corporate Affairs, Government of India ("MCA") vide its General Circular Nos. 14/2020 dated April 8, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 05, 2020, Circular No. 02/2021 dated January 13, 2021, Circular No. 21/2021 dated December 14, 2021, 02/2022 dated May 5, 2022, 10/2022 dated December 28, 2022 and latest being 09/2023 dated September 25, 2023, respectively, and other circulars issued in this regard ("MCA Circulars") allowed, inter-alia, for conduct of AGMs through Video Conferencing/ Other Audio-Visual Means ("VC/ OAVM") facility in accordance with the requirements provided in paragraphs 3 and 4 of the MCA General Circular No. 20/2020. The Securities and Exchange Board of India ("SEBI") also vide its Circular No. SEBI/HO/CFD/CMD2/ CIR/P/2021/11 dated January 15, 2021, Circular No. SEBI/HO/DDHS/P/CIR/2022/0063 dated May 13, 2022, SEBI/HO/CRD/PoD-2/P/CIR/2023/4 dated January 05, 2023 and Circular No. SEBI/HO/CFD/ CFD-PoD-2/P/ CIR/2023/167 dated October 07, 2023 ("SEBI Circular") has provided relaxations from compliance with certain provisions of the SEBI (Listing Obligations and Disclosure Requirements Regulations, 2015 ("Listing Regulations"). 3. A statement providing additional details of the Director(s) seeking appointment / re-appointment as set out at Item Nos. 3 & 4 of the Notice dated 14th June, 2024 is annexed herewith as required under Regulation 36(3) of the Listing Regulations and Secretarial Standard-2 on General Meetings issued by the Institute of Company Secretaries of India ('ICSI').
4. Since this AGM is being held through VC/OAVM, physical attendance of Members has been dispensed with in line with the MCA Circulars. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence, the Proxy Form and Attendance Slip are not annexed to this Notice.
5. Institutional/Corporate Shareholders (i.e. other than individuals/HUF, NRI, etc.) ("Body Corporates") are required to send a scanned copy (PDF/JPG Format) of its Board or governing body Resolution / Authorisation etc., authorising its representative to attend the AGM through VC/OAVM on its behalf and to vote through remote e-Voting. 6. The voting rights of Members shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date of Friday, 19th July, 2024.
7. Since the AGM will be held through VC / OAVM, the Route Map of the AGM venue is not annexed to this Notice.
8. In compliance with the aforesaid MCA and SEBI Circulars, the Notice of the AGM along with the Annual Report 2023-24 is being sent only through electronic mode to those Members whose email addresses are registered with the Company/ Depositories. For this purpose, it would not be necessary to register as a speaker.

14. Dividend on Company's Equity shares for the year ended 31st March 2024, as recommended by the Board of Directors, if approved at the AGM, will be payable (subject to deduction of tax at source) as under:
- To all Beneficial Owners in respect of shares held in dematerialized form as per the data as may be made available by the National Securities Depository Limited ("NSDL") and the Central Depository Services (India) Limited ("CDSL"), collectively "Depositories", as of the close of business hours on Friday, 19th July, 2024.
 - To all Members in respect of shares held in physical form after giving effect to valid Transfer, Transmission or Transposition requests lodged with the Company as of the close of business hours on Friday, 19th July, 2024.
- The Dividend, if approved, will be paid by 3rd August, 2024.
15. As per the provisions of the Act, dividends that are unclaimed/unpaid for a period of seven (7) years from the date of their transfer to the unclaimed/unpaid dividend account are required to be transferred to the Investor Education and Protection Fund ('IEPF') administered by the Central Government.

EXPLANATORY STATEMENT:

As required by Section 102 of the Act, the following Explanatory Statement sets out all material facts relating to the business mentioned under Item Nos. 4 & 5 of the accompanying Notice dated 14th June, 2024.

Item No. 4

Re-appointment of Mr. Mahesh Gupta (DIN: 00046810) as an Independent Director of the Company :

Mr. Mahesh Gupta, was appointed as an Independent Director at the 74th Annual General Meeting (AGM) held on 5th August, 2019, for a period of 5 years with effect from 30th April, 2019. Based on the recommendation of the Nomination and Remuneration Committee (NRC), the Board of Directors at its meeting held on 26th April, 2024, recommended the reappointment of Mr. Mahesh Gupta, for a Second term of five (5) consecutive years i.e. from 30th April, 2024, subject to the approval of the Members at the ensuing AGM and he shall not be liable to retire by rotation hereinafter in accordance with the provisions of the Act.

Mr. Mahesh Gupta, aged about 68 years, has about 4 decades of professional experience in the areas of Business Management and all dimensions of finance, M&As etc. He is serving as Independent Director on the board of CEAT Limited, RPG Life Science Limited and on the board of other Listed Companies.
