The Prohibited period commences from the date of posting the Agenda of the Audit Committee / Board Meeting in which the price sensitive information is to be considered and ending after 48 hours from the time the price sensitive information is made public.

The Agenda of Audit Committee/Board Meeting is proposed to be circulated during **second/third week of July 2024**; hence the Trading Window will be closed from the date of posting of Agenda until 48 hours from the date of declaration of the audited quarterly financial results by the Board.
