Non Compliance in appointment of Independent Director & non-compliance of composition of Audit, Nomination & Remuneration Committee.	Company's equity shares got listed on 29 th January 2021. During the period, the Board of Directors has five Directors comprising two Executive Directors (Govt. Nominees) and one Independent Director. Company should have three more Independent Directors in compliance of the Regulations 17 (1) (a) of SEBI (LODR) Regulations 2015. Also due to non-compliance in the appointment of optimum combination of Independent Directors in the Board of Directors, the Composition of Audit Committee, Nomination and Remuneration Committee were also not in consonance with the Regulations 2015. The company has submitted in its quarterly corporate governance report for the quarter ended 31 st March, 2021 to the Stock Exchanges that the Company is a Government Company. The power to appoint Directors vests with Government of India through Ministry of Railways (MoR) and Company has no role to play in it. The Company has already requested Government for appointment of Independent Directors, the listed entity could not comply with the provisions of Regulation 17(1)(a), 18 and 19 of the SEBI (LODR).
