Pursuant to the Regulation 30 of SEBI Listing Regulations, we hereby inform you that:-

- 1. A suit was filed by Luharuka Media & Infra Limited ("the Company") before Hon'ble Principal Special Court in the Cadre of District Judge for Trial and Disposal of Commercial Disputes at Hyderabad ("Commercial Court") against ICICI Bank Limited, Hyderabad and M/s. AMR India Limited.
- 2. With reference to aforesaid suit, it is to be noted that Hon'ble Commercial Court has passed an order dated March 15, 2024 wherein the suit is partly decreed with the cost by way of awarding
  - a. A sum of Rs. 72,00,000/- (Being Interest Amount);
  - b. Future interest at the rate 6% per annum on Rs.72,00,0000/- from the date of filing the suit i.e., April 16, 2021 to till the date of realization.

The information as required under Regulation 30 read with Schedule III of the SEBI Listing Regulations, SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as **Annexure I**.
