In that connection, the Lok Adalat, Visakhapatnam has disposed the matter by passing an order dated September 14, 2024 and imposing a fine of Rs. 26,000/- each on the Occupier (Mr. Gurdeep Soni-Promoter and Chairman & Managing Director) and Manager (Mr. Hari Buddhiraju – Previous Unit Manager). The fine has been paid as directed by the Lok Adalat.

2	Nature and details of the action(s) taken, initiated or order(s) passed	In the Visakhapatnam factory unit of Company, a contract worker fell from height and suffered multiple injuries and later succumbed to injuries. On July 27, 2023, four contract workers reported to duty for the work related to replacement of transparent sheet. Pursuant to bad weather on said day, the factory officials refused continuance of the transparent sheet replacement work and hence, did not issue permit to work to these workers. However, despite non-issuance of permit to work, all four workers went to the work location and started working and incident occurred with one of the contract workers. The Company reported the incident with Inspector of Factories and Deputy Chief Inspector of Factories, Visakhapatnam. Through Development Commissioner APSEZ, Company paid compensation amount of Rs. 14,95,500/- to the contract worker's family. Necessary corrective action was also taken at the incident site. The Occupier and Manager of unit of Company received summons' from the Additional Civil Judge (Junior Division), Yelamanchili, to which the Company's representative appeared for the hearings. At the hearing at Lok Adalat, Visakhapatnam on September 14, 2024, the Lok Adalat imposed a fine of Rs. 26,000/- each on Occupier and Manager of the unit of Company. The fine was paid by the Company on September 14, 2024, as directed by the Lok Adalat.
