**Annual General Meeting:** The 35th Annual General Meeting ('AGM') of the Company will be held over Video Conference/Other Audio-Visual Means (OAVM) on Wednesday, September 07, 2022 at 02:00 p.m.

**Fixing of Record Date for Dividend:** Pursuant to Regulation 42 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that, the Board of Directors in its meeting held today have fixed **August 19, 2022 (Friday)** as the '**Record Date**' for determining entitlement of the members to Final Dividend of Rs.1.50 per equity share of the face value of Rs.2 each for the financial year ended March 31, 2022.

If the dividend as recommended by the Board of Directors is approved at the AGM, payment of such dividend, subject to deduction of tax at source, will be made within 10 days from the date of declaration as under:
