Opinion

Nil , for the quarter and year ended 31st March 2020 respectively, total net profit (loss) of Rs.12.26 lakhs and Rs.(13.15) lakhs, for the quarter and year ended 31st March 2020 respectively, and net cash inflows/(outflows) of Rs.(0.79) lakhs for the year ended 31st March, 2020, as considered in the consolidated financial results. These financial statements have been audited by other auditor whose reports have been furnished to us by the Board of Directors and our opinion on the Consolidated Financial Results, in so far as it relates to the amounts and disclosures included in respect of this entity, is based solely on the report of such auditor and the procedures performed by us are as stated Auditor's Responsibility section above.
