Sub: Report on proceeding 16<sup>th</sup> Annual General Meeting of Sadbhav Infrastructure Project Limited (the Company) held on 30<sup>th</sup> September, 2022 through Video Conference ("VC") / Other Audio Visual Means (OAVM") facility.

With reference to the above, we wish to inform you that 16<sup>th</sup> Annual General Meeting of the Company held on 30<sup>th</sup> September, 2022 at 02:00 p.m. through Video Conference ("VC") / Other Audio Visual Means (OAVM") facility.

Mr. Hardik Modi, Company Secretary on behalf of the Company welcomed all Members, Directors, Stakeholders, Chief Financial Officer, Auditors, Invitees, Scrutinizer and Secretarial Auditor of the Company at the 16<sup>th</sup> Annual General Meeting (AGM) of the members of the Company. He also informed the members about the process to participate in the meeting and smooth conduct of AGM.

All Directors except Mrs. Daksha N. Shah, Independent Director of the Company attended the meeting, including Chairman of Audit Committee, Stakeholders Relationship Committee and Nomination and Remuneration Committee. Mr. Devansh Gandhi, Statutory Auditor and Mr. Ravi Kapoor, Scrutinizer were also present in the Meeting. It was confirmed that the meeting had the required quorum and the AGM to proceed. He further informed that the meeting was held through Video Conference ("VC") / Other Audio Visual Means (OAVM") facility is in accordance with circulars issued by the Ministry of Corporate Affairs (MCA) and Securities and Exchange Board of India (SEBI).

He informed the members that Mr. Shashin V. Patel, Chairman of the Company, occupied the Chair the meeting.



All requisite Statutory Registers were made available electronically on the website of the Company for inspection of the Members during the AGM.

The Company Secretary requested the Chairman to deliver his speech. The Chairman thereafter addressed the shareholders and gave his speech. Mr. Nitin Patel, Director of the Company had presented financial highlights of the Company.

With the permission of the Shareholders Notice convening the 16th Annual General Meeting and Directors' Report was taken as read.

He informed that, the Company has provided e-voting facility to all its members to enable them to cast their vote electronically on all the resolutions mentioned in the AGM notice. The e- Voting period commenced on Tuesday, 27th September, 2022 at 09.00 a.m. and ended on Thursday, 29th September, 2022 at 05.00 p.m. The cut-off date for determining the members who may cast their vote electronically was Friday, 23rd September, 2022. For those members who have not casted their vote through e-voting, can cast their vote during the course of the meeting through e-voting facility provided on CDSL e-voting website and the said facility is available for 30 minutes after the conclusion of Annual General Meeting. The qualification marked by the Statutory Auditor's Report in his report and reply of Director's in their report was also duly read before the members at the AGM.

Thereafter with the approval of Chairman of the meeting, the following businesses as mentioned in the notice of 16<sup>th</sup> Annual General Meeting were conducted:

## **Item No. 1** Resolution No. 1 for to consider and adopt:

- (a) the audited Standalone financial statement of the Company for the financial year ended 31<sup>st</sup> March, 2022, the reports of the Board of Directors and Auditors thereon; and
- (b) the audited Consolidated financial statement of the Company for the financial year ended 31st March, 2022 and the report of Auditors thereon.

# Item No. 2

Resolution No. 2 is an ordinary resolution for appoint of Director in place of Mr. Shashin V. Patel (DIN: 00048328), who retires by rotation and being eligible, offers himself for reappointment.

### Item No. 3

Resolution No. 3 is as an ordinary resolution for Ratification of Remuneration of Cost Auditor of the company.



### Item No. 4

Resolution No. 4 is as a special resolution for Approval of Loans, Investments, Guarantee or Security under Section 185 of Companies Act, 2013.

### Item No. 5

Resolution No. 5 is as a special resolution for Re-appointment of Mr. Vasistha C. Patel [DIN: 00048324] as Managing Director.

As mentioned earlier an opportunity is being given by way of e-voting to member who had not cast their vote through remote e voting.

Pursuant to the provisions of Section 109 of the Companies Act, 2013, Mr. Ravi Kapoor, Practicing Company Secretary has been appointed as Scrutinizer for conducting e-voting process. The results along with the scrutinizer's report would be submitted to the stock exchanges (BSE and NSE) within two working days of the conclusion of the meeting also would be placed on the website of the Company.

The Company Secretary requested the members registered as speakers to ask their queries. Mr. Nitin Patel had addressed the questions / queries raised by Shareholders of the Company.
