# OWNERSHIP TRANSFER MATTER IN NCLAT Jet lenders file plea against NCLT order

**LENDERS OF THE** erstwhile Jet Airways are reported to have approached the National Company Law Appellate Tribunal (NCLAT), opposing a January 13 National Company Law Tribunal (NCLT) order that states that the Jalan-Kalrock Consortium (JKC) — which was declared the winning bidder for the beleaguered airline — has fulfilled all the conditions precedent.

A plea was filed on Tuesday with the NCLAT by the lenders, CNBC TV18 reported citing sources.

Less than two weeks ago, the Mumbai bench allowed the applications filed by JKC against the lenders of Jet Airways, paving the way for transfer of ownership of the airline to JKC, 18 months after it was declared the winning bidder. The NCLAT agrees that all the conditions precedent provided in the resolution plan submit-

ted earlier have been met. The plan obligates the successful resolution applicant (by JKC) to recommence operations at Jet Airways.

The lenders, through their counsel, had sought a suspension of two weeks of the order, which was disallowed by the judges. Although there was no official statement from the lenders, the Street expected them to approach a higher

court to challenge the NCLT order.

With the effective date reset as November 16, JKC has until May to settle dues and take over management control of Jet Airways.

Last week, JKC moved the Supreme Court challenging an earlier order by the NCLAT, which had asked it to clear employees' dues totalling ₹250 crore.

# Vistara targeting to make FY23 its first-ever profitable year

**THE CURRENT FINANCIAL** year may turn out to be the first-ever profitable year at the operating level for full-service carrier Vistara, if it is able to tide over the lean March quarter through discount offers typically seen during this period.

The Tata group-promoted airline said that it has generated profits at each of the first three quarters this year, but at the operating level. At the net level, however, reasons like adverse foreign exchange fluctuations have restricted the company's attempts to become profitable.

Speaking to FE, Vinod Kannan, chief executive officer, Vistara, said, "We will definitely close the year with positive EBITDA. In the January-March quarter, we will try our best to ensure that there is an operating profit."

The company further said that it has been profitable at the EBITDA level from the start of the year. Including rent in the first two quarters, the company

did not make profits but during the December quarter all costs, including rental payments, have broken even.

A strengthening rupee against the US dollar in recent months, in addition to the returning leisure traffic of December and January, are the key pointers Vistara is betting on to continue its profitable run in the final quarter.

On Monday, without disclosing the absolute profit numbers for the quarter ended December, Vistara said its revenues during the April-December period surpassed \$1 billion, a first in its nine-year run.

Kannan added that Vistara is on course to augment its current fleet size by 32% through the addition of 17 aircraft by the end of 2024. He also said that the company is exploring the addition of multiple overseas locations to Indian cities, primarily Mumbai.

While Vistara's domestic network has grown to 50 flights a day from Mumbai, the city has got more international flights for the airline than Delhi. Mumbai is connected to Singapore,

Sources say Vistara is looking to add London to the list of destinations with the new Boeing 787, due for induction before April-end. The wide-body Boeing 787s are typically used for long-haul operations like on the India-Europe or India-US routes. Kannan

declined to share the airline's connectivity plans.

"We have three (Boeing) 787s, out of which two are owned and one is leased. We have four more to come in the next 12-15 months. By the end of FY24, we should be having all the 787s in our fleet," added Kannan.

Vistara is awaiting deliveries of five Airbus A321s besides the 787s. Supply chain issues that have created problems for all airlines in the world have led to delays in deliveries to Vistara as well. By the end of the year, Vistara hopes to have 60 aircraft in its fleet.

# Macrotech Developers Q3 net profit rises 41%

**REALTY FIRM MACROTECH** Developers on Tuesday reported a 41% increase in its consolidated net profit at ₹404.98 crore for the quarter ended in December.

Its net profit stood at ₹286.38 crore in the year-ago period, the company said in regulatory filing. However, the total income fell to ₹1,902.44 crore in the third quarter of this fiscal year from ₹2,155.70 crore in the corresponding period of the previous year.

# UK offer to Tata Steel unit to decarbonise operations falls far short of its demand

**THE BRITISH GOVERNMENT'S** offer of around £300 million to Tata Steel's UK business, to decarbonise its operations, falls far short of the steel major's demand of £1.5-billion aid.

When contacted, a Tata Steel official, however, declined to comment on it. He said the company is currently evaluating the British government's support package plans and that it will take some time to arrive at a final decision on the proposed package.

Tata Steel is the largest steelmaker in the UK, with primary steelmaking at Port Talbot in South Wales. Tata Steel UK (TSUK) has an annual crude steel capacity of 5 million tonne (mt) and it employs more than 8,000 people. It supplies steel products to demanding markets, including construction and infrastructure, automotive, packaging and engineering.

According to *The Financial Times*, British Chancellor of the Exchequer Jeremy Hunt is poised to sign off a support package for Tata Steel UK and British Steel, in a move that will be tied to Britain's two biggest steel manufacturers switching to green technology.

"The funding for British Steel and Tata Steel UK is likely to be unveiled by the chancellor, Jeremy Hunt, this week. Each is expected to receive around £300 million of grants to help pay for a switch away from coal-fired blast furnaces and help with energy costs," BBC reported.

Notably, Tata Steel is seeking £1.5 billion from the UK government to execute its decarbonisation plans. The company in the UK has the ambition to produce net-zero steel by 2050 at the latest, and to have reduced 30% of its CO2 emissions by 2030.

"Both Tata Steel UK and Tata Steel Netherlands have been developing detailed plans for transition to low CO2 technologies in line with our ambition to produce CO2-neutral steel by 2050 in Europe," the steel major had said in its annual report for 2021-22.

"Finalisation of decarbonisation roadmap for Tata Steel UK, focusing on utilisation of locally available steel scrap (the UK is the second highest producer in the world) in consultation with the UK Government,"

according to the annual report.

Tata Steel is reportedly seeking support from the UK government in two forms: In policy terms, by encouraging the transition to green steel and ensuring a cost-competitive landscape, and partnership in financing of the project, given the size of investment and the financially constrained position of the company's UK business.

Liquid steel production at Port Talbot Steel Works, Wales during the FY2021-22 stood at 3.5 mt, which was 0.2 mt higher than the previous year. Production during FY20-21 was partly impacted by demand reductions associated with the Covid-19 pandemic. During FY 2021-22, TSUK commissioned a new turbine within the power plant with capability of 30 Mwe internal power generation helping to reduce the reliance on external energy purchases.

# Tech startup Innovaccer cuts 245 global jobs, 50% in India

**HEALTHTECH STARTUP** Innovaccer has sacked 245 employees globally, across departments, as it realigns the business and aims to increase efficiency, people aware of the developments told FE. Of the total staffers impacted, about 50%, or around 120 of them, are from India, they added.

Innovaccer has a workforce of around 1,500 people, which will now be trimmed by 15%. The latest cost-cutting exercise comes after the Tiger Global-backed company fired around 100 employees from tech and other divisions in September.

The company has let go of staffers despite having a "rock-solid balance sheet". Confirming the development, Abhinav Shashank, co-founder and CEO, Innovaccer, said, "We are going to deprioritise certain areas and

offerings that distract us from our core portfolio, which will result in a reduction of workforce by approximately 15%."

"Innovaccer remains in a very strong financial position, with a rock-solid balance sheet, having raised more than \$425 million in capital with the majority still available for future investments," the company said in a statement.

Shashank, along with Kanav Hasija and Sandeep Gupta, founded Innovaccer in 2014. The company is a software-as-a-solution (SaaS) platform, which helps clients tie healthcare data with several systems and settings for large corporations and hospitals, especially in the US. The San Francisco and Bengaluru-based startup joins a growing list of new-age companies which have let employees go as they pave their path towards profitability and realign businesses.

**THE BRITISH GOVERNMENT'S** offer of around £300 million to Tata Steel's UK business, to decarbonise its operations, falls far short of the steel major's demand of £1.5-billion aid.

When contacted, a Tata Steel official, however, declined to comment on it. He said the company is currently evaluating the British government's support package plans and that it will take some time to arrive at a final decision on the proposed package.

Tata Steel is the largest steelmaker in the UK, with primary steelmaking at Port Talbot in South Wales. Tata Steel UK (TSUK) has an annual crude steel capacity of 5 million tone (mt) and it employs more than 8,000 people. It supplies steel products to demanding markets, including construction and infrastructure, automotive, packaging and engineering.

According to *The Financial Times*, British Chancellor of the Exchequer Jeremy Hunt is poised to sign off a support package for Tata Steel UK and British Steel, in a move that will be tied to Britain's two biggest steel manufacturers switching to green technology.

"The funding for British Steel and Tata Steel UK is likely to be unveiled by the chancellor, Jeremy Hunt, this week. Each is expected to receive around £300 million of grants to help pay for a switch away from coal-fired blast furnaces and help with energy costs," BBC reported.

Notably, Tata Steel is seeking £1.5 billion from the UK government to execute its decarbonisation plans. The company in the UK has the ambition to produce net-zero steel by 2050 at the latest, and to have reduced 30% of its CO2 emissions by 2030.

"Both Tata Steel UK and Tata Steel Netherlands have been developing detailed plans for transition to low CO2 technologies in line with our ambition to produce CO2-neutral steel by 2050 in Europe," the steel major had said in its annual report for 2021-22.

"Finalisation of decarbonisation roadmap for Tata Steel UK, focusing on utilisation of locally available steel scrap (the UK is the second highest producer in the world) in consultation with the UK Government,"

according to the annual report.

Tata Steel is reportedly seeking support from the UK government in two forms: In policy terms, by encouraging the transition to green steel and ensuring a cost-competitive landscape, and partnership in financing of the project, given the size of investment and the financially constrained position of the company's UK business.

Liquid steel production at Port Talbot Steel Works, Wales during the FY2021-22 stood at 3.5 mt, which was 0.2 mt higher than the previous year. Production during FY20-21 was partly impacted by demand reductions associated with the Covid-19 pandemic. During FY 2021-22, TSUK commissioned a new turbine within the power plant with capability of 30 Mwe internal power generation helping to reduce the reliance on external energy purchases.

# Tech startup Innovaccer cuts 245 global jobs, 50% in India

**HEALTHTECH STARTUP** Innovaccer has sacked 245 employees globally, across departments, as it realigns the business and aims to increase efficiency, people aware of the developments told *FE*. Of the total staffers impacted, about 50%, or around 120 of them, are from India, they added.

Innovaccer has a workforce of around 1,500 people, which will now be trimmed by 15%. The latest cost-cutting exercise comes after the Tiger Global-backed company fired around 100 employees from tech and other divisions in September.

The company has let go of staffers despite having a "rock-solid balance sheet". Confirming the development, Abhinav Shashank, co-founder and CEO, Innovaccer, said, "We are going to deprioritise certain areas and

offerings that distract us from our core portfolio, which will result in a reduction of workforce by approximately 15%."

"Innovaccer remains in a very strong financial position, with a rock-solid balance sheet, having raised more than \$425 million in capital with the majority still available for future investments," the company said in a statement.

Shashank, along with Kanav Hasija and Sandeep Gupta, founded Innovaccer in 2014. The company is a software-as-a-solution (SaaS) platform, which helps clients tie health-care data with several systems and settings for large corporations and hospitals, especially in the US. The San Francisco and Bengaluru-based startup joins a growing list of new-age companies which have let employees go as they pave their path towards profitability and realign businesses.

जान गंवाने वाली महिला की भाभी माही संधु ने वारदात की बाबत जानकारी देते हुए बताया कि उस समय वह फोन पर बात कर रही थी और उनके कानों में चीखने-चिल्लाने की आवाजें आई थीं। उन्होंने बताया, मैं उन्हें अनजान लोगों के लिए घर का गेट नहीं खोलने को कह रही थी और उसके चंद मिनट में ही यह वारदात हो गई। उन्होंने बताया कि बदमाशों ने घर में घुसकर वारदात को अंजाम देने से

पहले उनके छोटे बेटे को बांध दिया था। उन्होंने यह भी कहा कि परिवार में उनकी बेटी की हाल ही में शादी हुई थी और हो सकता है कि घर के सेफ में कुछ स्वर्णभूषण और नकदी उसमें रखी भी हो, क्योंकि जब वह घर में वारदात की जानकारी मिलने पर वहां पहुंची तो सेफ खुला पड़ा था। बस्ती बाबा खेल इलाके के थाना प्रभारी सहायक उप-निरीक्षक बलवंत सिंह ने बताया कि वहां यह बदमाश घर में लूटपाट करने के ही इरादे से घुसे थे। जब वह वहां घर में दाखिल हुए तो जान गंवाने वाली महिला का बेटा कमरे में सो रहा था जिसे पहले ही बदमाशों ने उसके कमरे में बंद कर दिया था, जबकि घर में काम करने वाली घरेलू नौकरानी घर की छत पर काम करने ऊपर गई हुई थी। जब वह काम खत्म करके वहां नीचे उतरी तो कमलजीत कौर को घर के अंदर खून में

हरियाणा के खाप नेताओं ने हरियाणा सरकार में मंत्री संदीप सिंह के खिलाफ मोर्चा खोलते हुए ऐलान किया है कि 26 जनवरी को उन्हें तिरंगा नहीं फहराने दिया जाएगा। धनखड़ खाप के अध्यक्ष युद्धवीर धनखड़ के नेतृत्व में कई खापों के प्रतिनिधि आज मंगलवार यहां चंडीगढ़ पहुंचे और यहां चंडीगढ़ पुलिस के

महानिदेशक के साथ बैठक की। बैठक में डागर खाप के प्रधान वरिंदर डागर, रामकुमार डागर, कादियान खाप के प्रधान बिल्लू प्रधान, महिला कोच के पिता, गुलिया खाप के जयपाल सहित कई नेता शामिल थे। डीजीपी से मुलाकात में खाप नेताओं ने अब तक कोई सकारात्मक कार्रवाई नहीं किए जाने पर भी रोष व्यक्त किया। खाप नेताओं ने आरोप लगाया कि पिछले 24 दिनों में चंडीगढ़ पुलिस मामले दर्ज करने के बाद चुप बैठ गई है। इस मामले में आरोपी को गिरफ्तार नहीं किया गया है। दूसरी तरफ हरियाणा सरकार आरोपी को बचाने में लगी हुई है। अब सभी नियमों को ताक पर रखकर संदीप सिंह को पिहोवा में झंडा फहराने का कार्यक्रम सौंप दिया गया है। खाप नेताओं ने डीजीपी से बैठक के बाद

पत्रकारों को बताया कि डीजीपी ने उन्हें अब तक कोई कार्रवाई के बारे में तो कुछ अधिक नहीं बताया है, अलबत्ता बहुत जल्द इस मामले में कार्रवाई सबके सामने आने की बात कही। खाप नेताओं ने कहा कि डीजीपी ने भरोसा दिलाया कि है एसआईटी की जांच अंतिम चरण में है और बहुत जल्द एसआईटी रिपोर्ट सौंपेगी। इसके आधार पर अगली कार्रवाई की जाएगी। खाप नेताओं ने कहा कि इस बारे में धनखड़ खाप तथा अन्य सभी खापों की सर्वखाप पंचायत हो चुकी है। हरियाणा सरकार इसे गंभीरता से नहीं ले रही है। अब खाप पंचायतों ने फैसला किया है कि संदीप सिंह को 26 जनवरी को झंडा नहीं फहराने दिया जाएगा। संदीप सिंह अगर गणतंत्र दिवस पर झंडा फहराता है तो वह राष्ट्रीय ध्वज का अपमान करेगा। खापों ने गणतंत्र दिवस के

मौके पर संदीप सिंह का पुतला फूंकने का ऐलान करते हुए कहा कि हरियाणा की सभी खापें पूरी एकजुटता के साथ बेटी को ईसाफ दिलवाने के लिए लड़ाई लड़ेंगी। खाप नेताओं ने कहा कि वह इस मामले को लेकर मुख्यमंत्री व गृहमंत्री से भी मुलाकात कर चुके हैं। पीड़िता भी गृहमंत्री से मुलाकात कर चुकी है लेकिन अभी तक गृहमंत्री ने भी कोई कार्रवाई नहीं की है। हरियाणा सरकार द्वारा जो फैक्ट फाईंडिंग कमेटी बनाई गई है उसने आजतक कुछ नहीं किया। हरियाणा पुलिस की कमेटी केवल आंखों में धूल झाँकने के लिए बनाई गई है। खाप नेताओं ने कहा कि सरकार व पुलिस ने यदि मामले में ठोस कार्रवाई नहीं की तो जल्द सर्वखाप पंचायत बुलाकर बड़ा फैसला लिया जाएगा जिसका असर सरकार और पुलिस को पूरे प्रदेश में दिखाई देगा।

## पंजाब में दो महिला आइपीएस अधिकारी डीजीपी पद पर पदोन्नत

वरिष्ठ भारतीय पुलिस सेवा- आईपीएस अधिकारी गुरप्रीत कौर देव और शशि प्रभा द्विवेदी पुलिस महानिदेशक पद पर प्रोन्नत होने वाली पंजाब काडर की पहली महिला अधिकारी बन गई हैं। एक आधिकारिक आदेश के मुताबिक, वह सन् 1993 बैच के उन सात आईपीएस अधिकारियों में शामिल हैं जिन्हें डीजीपी के रूप में पदोन्नत किया गया है। जिन अन्य अधिकारियों को डीजीपी पद पर पदोन्नत किया गया है उनमें सतर्कता ब्यूरो के मुख्य निदेशक वरिंदर कुमार, मानव संसाधन विकास के एडीजीपी ईश्वर सिंह, पंजाब राज्य ऊर्जा निगम लिमिटेड के एडीजीपी जितेंद्र कुमार जैन, पुलिस और नियमों के एडीजीपी एस के अस्थाना तथा आंतरिक सुरक्षा के एडीजीपी आर एन टोके शामिल हैं। सात एडीजीपी को डीजीपी पद पर पदोन्नत किया गया है। इसके साथ ही अब पंजाब में डीजीपी दर्जे के 13 अधिकारी हो गए हैं।

## जवाहर यादव होंगे मुख्यमंत्री मनोहर लाल के विशेष कार्यकारी अधिकारी

चंडीगढ़: हरियाणा सरकार ने गुरुग्राम वासी जवाहर यादव को मुख्यमंत्री मनोहर लाल खट्टर का नया विशेष कार्यकारी अधिकारी- ओएसडी नियुक्त किया है। जवाहर यादव दूसरी बार मुख्यमंत्री कार्यालय में प्रवेश कर रहे हैं। आज मंगलवार मुख्य सचिव संजीव कौशल ने उनके नियुक्ति आदेश जारी किए। वर्ष 2014 में भी उन्हें सबसे पहले तैनाती दी गई थी।

प्रदेश के किसान पिछले करीब एक सप्ताह से चीनी मिलों पर ताला जडकर मिलों के बाहर धरना दे रहे हैं। हरियाणा में इस समय गन्ने की कीमत 362 रुपये प्रति क्विंटल है। किसान संगठनों के विरोध के बीच सरकार द्वारा कृषि मंत्री जे.पी. दलाल की अध्यक्षता में एक रिव्यू कमेटी का गठन किया गया है। यह कमेटी दो बैठकें कर चुकी है। मंगलवार को कमेटी की तीसरी बैठक हुई। करीब दो घंटे तक चली इस बैठक में गन्ने की लागत एवं बाजार में चीनी के मूल्य से संबंधित विभिन्न मुद्दों पर विस्तार से चर्चा की गई।
