

कामटे, साथीदारांकडून कोथळेचा कट रचून खून सरकारी वकिलांचा युक्तिवाद

सांगली, ता. ५ : बडतर्फ पोलिस उपनिरीक्षक युवराज कामटे यांच्यासह साथीदारांनी कट रचून अनिकेत कोथळे याचा खून केल्याचा युक्तिवाद विशेष सरकारी वकील उज्वल निकम यांनी आज न्यायालयासमोर केला. कामटेसह साथीदारांवर दहा आरोप निश्चित करावेत, अशी विनंतीही केली.

या प्रकरणाची जिल्हा न्यायाधीश एस. एस. सापटणेकर यांच्यासमोर सुनावणी सुरू आहे. एका गुन्हाच्या तपासासाठी कामटे आणि त्याच्या साथीदारांनी चौकशीदरम्यान केलेल्या

मारहाणीत अनिकेतचा मृत्यू झाला होता. हे प्रकरण उघडकीस आल्यानंतर दबाव आल्यानंतर कामटेसह इतरांना अटक करण्यात आली. राज्य गुन्हे अन्वेषण विभागाने याचा सखोल तपास करून दोषारोपपत्र न्यायालयात सादर केले.

याप्रकरणी कामटेसह अनिल लाड, अरुण टोणे, नसिरुद्दीन मुल्ला, राहुल शिंगटे, स झाकीर पट्टेवालेवर यांनी अनिकेतचा खून केल्याचा आरोप १६ ऑक्टोबरला प्रस्तावित करण्यात आला होता. त्यानुसार आजच्या सुनावणीत सर्व आरोप निकम यांनी न्यायालयासमोर ठेवले. त्यावर बचाव पक्षाचे म्हणणे सादर होणार असून त्यानंतर यावर आदेश दिले जाण्याची शक्यता आहे.
