अलिबाग : खासगी विकासकाच्या फायद्यासाठी सरकारी निधीचा वापर करून नाल्याच्या ठिकाणी रस्ता बांधण्याचा घाट रोहा नगरपरिषद प्रशासनाने घातला असून त्याठिकाणी आजही काम चालू असल्याचा आरोप माजी उपनगराध्यक्ष जितेंद्र दिवेकर यांनी केला आहे. जिल्हा प्रशासनाकडून फक्त बैठका घेऊन वेळकाढूपणा करित असल्याचे त्यांचे म्हणणे असून प्रशासनाने तातडीने निर्णय घेतल्यास आपण न्यायालयात धाव घेणार आहोत, असा इशारा माजी उपनगराध्यक्ष जितेंद्र दिवेकर यांनी दिला आहे.

नाल्याच्यालगतच १४ मजली इमारत बांधणीचे काम सुरु आहे. बांधकाम होत असलेल्या जागेमध्ये येण्या-जाण्यासाठी रस्ता नाही. त्यामुळे नगरपरिषदेने १ कोटी ५० लाख रुपये खर्च करून नाल्यावर स्लॅब टाकण्यास सुरुवात केली आहे. सातमशी गटाराची जागा एमआयडीसीच्या मालकीची आहे. या जागेशी रोहा नगरपरिषदेचा काहीही संबंध नसताना, विकासकाच्या फायद्यासाठी जिल्हा नियोजन समितीमार्फत निधी मंजूर करून बेकायदेशीररित्या सरकारच्या निधीचा अपव्यय होत असल्याचा आरोप दिवेकर यांनी करत नगरपरिषद प्रशासनाकडे तक्रार
