Sub: Report of Scrutinizer for e-voting Process vide Notice Dated 25th June, 2021 under section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 by Jumbo Bag Limited ('the Company').

In the meeting of the Board of Directors of Jumbo Bag Limited held on 25th June, 2021, through Video Conference, I, Mrs. Lakshmi Subramanian, Practicing Company Secretary, was appointed as Scrutinizer for process of voting through electronic means ("e-voting") issued in accordance with General Circular No. 14/2020, 17/2020 and 20/2020 dated 8 April 2020, 13 April 2020 and 5 May 2020 respectively, issued by Ministry of Corporate Affairs (MCA) (hereinafter referred to as "MCA Circulars"), Government of India, hereby calling the Thirty First Annual General Meeting of its Equity Shareholders ("the Meeting" /"AGM") through VC / OAVM. The AGM was convened on Saturday, 14th August 2021 at 10:45 a.m through VC / OAVM as per section 110 of the Companies Act, 2013 ('Cos Act') for passing of the items of Ordinary business and Special business as Ordinary resolution and special resolution by the members of the Company:

The Company has availed the e-voting facility from Central Depository Services (India) Limited for the shareholders to cast their votes to the aforesaid resolution through electronic mode. Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 recognizes voting by electronic mode, which prescribed the appropriate mechanism for e-Voting.

The e-Voting process was accordingly conducted and concluded as below:

- The Company has dispatched the notice under section 110 of the Companies Act, 2013, through E-Mail on 22nd July, 2021 to all the members of the Company whose name appeared on the Register of Members/ List of Beneficiaries as on 16thJuly, 2021 and total number of members as reported by RTA was 2806^{N/A}
- The Company issued an advertisement in Financial Express

 MalaiTamilagam about the dispatch of e-voting notice on 22ndJuly 2021

- All the members of the Company whose name appeared on the Register of Members/List of Beneficiaries as on 7th August 2021 and total number of members as reported by RTA was 5224 were entitled to vote for the resolutions set out in the AGM.
- The e-voting commenced on Wednesday, 11th August, 2021 (09.00 hours IST) and was open up to the close of working hours Friday, 13th August, 2021 (17.00 hours IST) and the e-voting at the time of AGM commenced on 14th August, 2021 from 11.20 am to 11.35 am provided 15 minutes time for e-voting.
- All electronic votes received up to the close of working hours at 17.00 hours IST on 14th August, 2021 and received at the time of Annual General Meeting were considered for my scrutiny.
- The votes cast by the members through electronic voting system was downloaded and collected from the website www.evotingindia.com was sent by RTA on 14th August 2021.
- A register containing the details of assent or dissent, received, mentioning the
 particulars of name, address, folio number / client ID of the shareholders, the
 number of shares held by them, the nominal value of shares held etc is
 maintained in electronic form.

Based on the data, reports and statements collected as mentioned above, the scrutiny was completed and results were compiled as under.
