This is to inform you that ICICI Prudential Mutual Fund (the Fund) under its various schemes holds equity shares of EPL Limited (the company), listed on your stock Exchange.

The Fund under its scheme has carried out sale of 2,83,094 shares of the Company on November 03, 2023. As a result, the shareholding of the Fund has decreased by 2.04% of the paid-up capital of the company as compared to previous disclosure on February 06, 2023 for 7.36%.
