# G20 stops short of denouncing protectionism, warns of slowdown

Calls for 'free, fair, non-discriminatory' trade environment

**LEIKA KIHARA** Osaka, June 29

**LEADERS OFTHE** Group of 20 major economies warned on Saturday of growing risks to the global economy but stopped short of denouncing protectionism, calling instead for a free, fair trade environment after talks some members described as difficult.

In a communique at the end of a two-day meeting in Japan's western city of Osaka, the leaders said global growth remained low and risks were tilted to the downside, as trade and geopolitical tensions have grown.

"We strive to realise a free, fair, nondiscriminatory, transparent, predictable and stable trade and investment environment, and to keep our markets open," they said in a second successive summit statement that

refrained from urging the need to resist protectionism. Japanese PM Shinzo Abe put on a brave face, stressing the G20 leaders had much in common, such as a shared recognition of the need for the group to remain key drivers of global growth.

"The G20 agreed on fundamental principles backing a free trade system," Abe said, adding that the group had also pledged stronger action to improve the dispute settlement system of the WTO. In preparing the G20 statement, Japan, the chair of the meetings, has sought common ground between the US, which opposes language denouncing protectionism, and other nations seeking

a stronger warning against trade tension. "There were no breakthrough decisions but ... all participants have confirmed their aspiration to work further on improving the global trade system, including the aspiration to work on WTO reform," Russian President Vladimir Putin told a news conference on Saturday. "The fact that all have confirmed the need of this process and their readiness to work toward this process is already positive."

#### Resuming talks insufficient

Widening fallout from the United States-China trade war has jolted markets and tested the resolve of G20 members to present a united front in averting a global recession.

The US and China agreed to restart trade talks, offering some hope that the world's two largest economies can resolve the bitter dispute. The EU and South American bloc Mercosur agreed a free trade treaty on Friday, committing to more open markets in defiance of the rising tide of protectionism. "This deal promotes our values

and supports a multilateral, rulesbased system," European Commission President Jean-Claude Juncker told reporters on Saturday, taking a swipe at US President Donald Trump's aversion to multilateralism. However, Christine Lagarde, MD of the International Monetary Fund, warned the global economy had hit a "rough patch" due to the trade conflicts, and urged G20 policymakers to reduce tariffs and other trade obstacles.

"While the resumption of trade talks between the US and China is welcome, tariffs already implemented are holding back the global economy, and unresolved issues carry a great deal of uncertainty about the future," she said in. Last year's G20 summit in Buenos Aires was the first to drop the language on the need to denounce protectionism, deferring to a request by Washington, which is sensitive to criticism of the tariffs it is slapping on some G20 members.

# States get 1-yr deadline to roll out 'one nation, one ration card'

PRESS TRUST OF INDIA New Delhi, June 29

THE CENTRE HAS given states and Union Territories time till June 30,2020 to roll out the 'one nation, one ration card'system, under which beneficiaries can buy subsidised foodgrains from ration shops in any part of the country.

Food minister Ram Vilas Paswan said 10 states—Andhra Pradesh, Gujarat, Haryana, Jharkhand, Karnataka, Kerala, Maharasthra, Rajasthan, Telangana and Tripura—are already providing portability of PDS entitlements. "By next June 30, 2020, 'one nation, one ration card' should be implemented without fail in the entire country.We have written letters to the state government to fast track the implementation of this system," Paswan told reporters.

The new mechanism will ensure no poor is deprived of PDS entitlement if that person shifts from one place to another. The system will also help rem-

ove fake ration card holders, he added. Paswan further said there are 11 states, including Tamil Nadu, Punjab, Odisha and Madhya Pradesh, which can easily implement PDS portability within their state as Point of Sale (PoS) machines have been

installed in all ration shops.

This is one of the 100-days agenda of the Modi 2.0 government, he added. Since November 2016, the government is implementing the National Food Security Act, under which foodgrains are supplied every month at highly subsidised rates of ₹1–3 per kg to over 80 crore people in the country. Elaborating about the new

system, Paswan said beneficiaries are required to show their Aadhaar card to buy foodgrains from any ration shop in the country. Only ration card would suffice if beneficiaries want to get their PDS entitlement only from a particular registered

So far, Aadhaar cards of about 89% of beneficaries have

been linked with the system, while 77% of ration shops have installed PoS machines, he said.

As many as 22 states have 100% PoS coverage and there is no problem in implementing the new system. Delhi had rolled out portability of PDS entitlement a year back but later stopped, Paswan added.

Commenting on whether a beneficiary who moves to another state where PDS foodgrain is given for free is entitled for the same, a senior food ministry official said, "In such cases, the beneficiary will get the entitlement as per the rates fixed by the Centre, that is ₹1-3 per kg."

To ensure that one member of a family after shifting to another place does not buy the entire family quota in one go, a maximum limit of buying will be fixed, the official said.

In such cases, the beneficiary will be allowed to buy maximum 50% of the family quota. This would ensure other members are not deprived of their entitlement, he added.

## US outlier as G20 split over climate change

Osaka, June 29

AFTER MUCH WRANGLING, the Group of 20 major economies on Saturday agreed to disagree on fighting climate change, with the US dissenting from a commitment to carry out the 2015 Paris climate change agreement.

In a communique at the end of the summit, the grouping said "signatories to the Paris Agreement" reaffirmed their commitment to its full implementation, referring to the 19 members aside from the US. The US withdrew from the Paris pact because it "disadvantages American workers and taxpayers," the grouping added in a subsequent section, adopting a two-part approach used at last year's summit in Buenos Aires.

The division reflects tussles over global warming that have repeatedly stymied international forums since Trump pulled the US out of the landmark accord to limit the effects of climate change.

Even before the summit started, the differences over climate change became apparent when President Emmanuel Mac-

ron said France would not accept a final text that omitted the Paris pact. In that accord, 200 nations agreed to limit the global average rise from pre-industrial temperatures to below 2°C (3.6°F). Current policies put the world on track for a rise of at least 3°C by the end of the century, the UN said in a 2016 report, however. G20 officials said the talks to secure acceptable language on climate change were contentious.

The first chunk of text reflecting the majority view said members had "common but differentiated responsibilities and respective capabilities" in implementing the pact. The section on the American stance said the US employed a "balanced approach to energy and environment" to deliver "affordable, reliable, and secure energy to all its citizens".

The US approach uses "all energy sources and technologies, including clean and advanced fossil fuels and technologies, renewables, and civil nuclear power, while reducing emissions and promoting economic growth," it said. **REUTERS**

### China, US agree to restart trade talks HUAWEI HAS COME under

mounting scrutiny for over a year, led by US allegations that "back doors" in its routers, switches and other gear could allow China to spy on US communications.

While the company has denied its products pose a security threat, the United States has pressed its allies to shun Huawei in their fifth generation, or 5G, networks and has also suggested it could be a factor in a trade deal. The problems at Huawei have filtered across to the broader chip industry, with Broadcom warning of a broad slowdown in demand and cutting its revenue

In a lengthy statement on the two-way talks, China's foreign ministry quoted Xi as telling Trump he hoped the United States could treat Chinese companies fairly. On the issues of sovereignty and respect, China must safeguard its core interests, Xi was cited as saying. "China is sincere about continuing negotiations with the United States... but negotiations should be equal and show mutual respect," the foreign ministry quoted Xi as saying.Trump had threatened to extend existing tariffs to almost all Chinese imports into the United States if the meeting brought no progress on wideranging US demands for

Financial markets are likely to breathe a sigh of relief on news of the resumption in US-China trade talks."Returning to negotiations is good news for the business community and breathes some much needed certainty into a slowly deteriorating relationship," said Jacob Parker, a vice-president of China operations at the US-China Business Council. "Now comes the hard work of finding consensus on the most difficult issues in the relationship, but with a commitment from the top we're hopeful this will put the two sides on a sustained path to resolution,"he

Some, however, warned the pause might not last. "Even if a truce happens this weekend, a subsequent breakdown of talks followed by further escalation still seems likely," Capital Economics said in a commentary on Friday.

### Govt to soon finalise IT intermediary guidelines

THAT APART, FOR intermediaries with more than 50 lakh members, the draft proposes that such entities need to be registered with the Registrar of Companies (RoC), have a permanent office in India and appoint a nodal person to coordinate with law enforcement agencies. Also, if they receive a court order or a notification from a government agency, they should act and remove unlawful content within 24 hours.

The draft guidelines have generally received a negative response from the IT industry, which termed it as arbitrary, violating right to privacy and financially unviable. Several IT and tech companies even registered their objections regarding the policy in the counter comments invited by MeitY.

### Hope for stronger urban housing scheme foundation

HOWEVER, BY END of May 2019, more than 80.96 lakh homes have already been sanctioned in urban areas under PMAY and 61% are already completed or occupied.

"These initiatives have seen

record investment, speed, use of technology and public participation. We are committed to further improving urban infrastructure. No stone will be left unturned to fulfil the dream of housing for all, which will give wings to crores of aspirations,"

read another tweet by Modi on Tuesday.

PMAY (U) envisages to be implemented during 2015-2022 through assistance from the Centre to urban local bodies or other state-level agencies. The execution is done through four verticals — rehabilitation of existing slum dwellers using land as a resource through private participation, credit-linked subsidy, affordable housing in partnership, and subsidy for beneficiary-led individual house construction or enhancement.

As per the first method, a slum dweller can get up to Rs 1 lakh for redevelopment using own land as resource with help of a private developer.

Under the credit-linked subsidy — which was extended for middle income group as well from January 1, 2017, apart from economically weaker section (EWS) and low-income group (LIG) — beneficiaries are eligible for an interest subsidy of 6.5% on loans up to Rs 6 lakh for a 20year tenure, wherein the net present value of loan is calculated at a discount of 9%.

Under the third arrangement, the Centre provides Rs 1.5 lakh per EWS house for projects that have at least 35% units for EWS category and have least 250 houses. And finally, an eligible EWS beneficiary can seek Rs 1.5 lakh of central assistance to build a house on her own land.

The size of the house eligible for the scheme for the EWS families is 30 square metre; however, states can decide to increase the size in consultation with MoHUA. The beneficiary EWS family has been defined as one with annual income of Rs 3 lakh and LIG as one with an annual income of Rs 3-6 lakh.

However, while the government has brought down GST rate from 5% to 1% already, there are some issues which need to be sorted. "One of the things is that banks should be providing funding for land. This will increase a lot of demand for affordable houses as land ownership is an issue," said Anuj Puri, chairman, ANAROCK Property Consultants. At present, a beneficiary needs to own land to avail the benefit, but debt is not available to buy land. The other change that the government might bring is to extend the benefits presently available only for projects approved up to March 31, 2019.

Under PMAY (Gramin), the target number of houses to be constructed by the year 2021-22 is 2.95 crore. In the first phase, one crore houses were taken up for construction in three years between 2016 and 2019. In the second phase, 1.95 crore houses are targeted for construction between 2019 and 2022. The government provides Rs 1.5 lakh to each eligible beneficiary to construct a house under PMAY

### Foreign stars and desi brands

APART FROM INDIA, Micromax operates in Russia, the Middle East, Nepal, Bangladesh and Sri Lanka and earns a paltry 11% of its revenue from exports.

Later in 2016, Micromax shifted gears to promote a local language feature in its phones and ended up dropping Jackman for TV host Kapil Sharma, thereby undoing the aspirational value proposition of the brand. An international endorser may not always be the magic wand, after all.

Most recently, OnePlus endorser for China and India. Robert Downey Jr, has taken over the entire premium out-ofhome ad inventory in metro cities — an all-out attempt by OnePlus to win the Indian market with a trending brand ambassador, due to the recently released Avengers: Endgame movie. In the smartphones market that is cluttered with too many celebrities, OnePlus has tried to break away with an international face. The brand has earned flak for this move because as a brand that promises to offer the best features at affordable prices, investing in a premium star like Downey Jr likely goes against its value for money proposition. International faces have

mostly been associated with automotive or smartphone brands. Historically, one atypical brand to sign on an international face was Indian textile brand Vimal. Sir Vivian Richards swaying by the pool to Caribbean music in an ad for Vimal in 1987 positioned the company as upmarket. Uboweja says not many brands can pull off such a casting coup. "Product categories that connect with a relatively young, affluent and outward-looking target audience can benefit from global endorsements," he says.

Forbrands that wish to sign on celebrities, international stars are a great choice simply because of their "consistency and professionalism", says Pallavi Singh, head marketing, Morris Garages India. And contrary to popular belief, a star from across the seven seas is not necessarily more expensive than an Indian A-list star, unless one talks of prime stars like DowneyJr. Experts say since the star is being signed on just for one market, the cost is typically low.

As per conservative industry estimates, even if an international star charges half the fee of an Alist Indian celebrity, it would amount to ₹4-5 crore per day, which is a decent bargain for advertisers.

Aditya Gadiyar, brand head, VIP, points out that in most cases international faces represent brands for a limited period — typically for a product launch. This, too, brings down the cost of the association. In fact, the Morris Garages association with Cumberbatch came at a "modest fee", says Singh. The only factor that raises the cost is logistics, she points out, because the television commercial shoot needs to happen abroad.

According to Gadiyar, an international celebrity that comes at a steal is particularly preferable over an Indian star as it allows the brand to plough back the budget saved on the ambassador into media buying.




