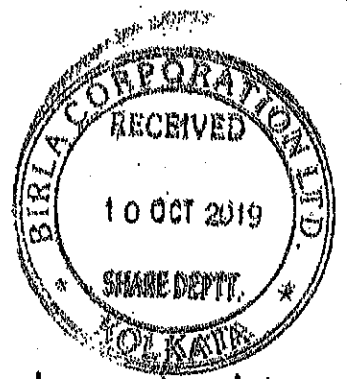

Sir, As per your earlier mail (dated on 24/09/2019) you have mentioned that as per your records, Total 90 shares of your company are held under folio no. → 0002162.


