We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of **MANGALORE REFINERY AND PETROCHEMICALS LIMITED ("The Company")** for the quarter ended 30<sup>th</sup> June 2019 ("the Statement") attached herewith being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ("The Regulation"), read with SEBI circular No.CIR/CFD/CMD1/44/2019 dated March 29,2019 ("The Circular").
