Dear Sir/Madam,

With reference to our disclosure of outcome of Board Meeting dated January 18, 2024, we would like to inform you that the PK Healthcare Pvt. Ltd. ("PKHPL") at its meeting of Board of Directors held today, i.e. on January 25, 2024 has allotted 10,00,00,000 Equity Shares of the face value of Rs. 10/- each to the Company (i.e. 73.20%) under Preferential Issue. Post aforesaid allotment, PKHPL has become a Subsidiary of the Company.

The Company has also acquired balance 14.06% equity shares from Mr. Naresh Kapoor (erstwhile Promoter of PKHPL) through execution of Share Purchase Agreement by way of secondary purchase which was approved by PK Healthcare Pvt. Ltd.

The Company is now holding 87.26% stake in PKHPL, Further to that, the subsidiary of PKHPL, namely M/s. Ningen Lifecare Private Limited has now become 100% step-down subsidiary of the Company.
