Subject: Clarification Regarding GST Demand Letter

Dear Sir/Madam,

This is with reference to your mail dated 23.08.2023 and our disclosure dated 20.08.2024 under Regulation 30 of LODR regarding receipt of a Demand Notice from Central Goods & Services Tax Office. In this regard, please note that the company has made all the required disclosures as mentioned in SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 on 20th August 2024. With regard to your observations regarding delay in disclosing the information, we would like to submit as under:

Emmforce Autotech Limited, was previously operating as a partnership firm before its conversion into a limited company in October 2023. Subsequently the company got listed on SME Platform of BSE Limited. Due to this transition, there was changes in GSTIN credential as well as updation of official email IDs used for communication. The aforesaid demand of GST was pertaining to the period when the company was operating as a partnership firm. The GST Department issued an order on 16.08.2024 which was communicated to us at an email address associated with erstwhile partnership firm, which is no longer in use. Further we were informed about the order via phone on 20.08.2024, after which we promptly checked the GST portal and identified the issue. We immediately updated our records and sent the required information to BSE as per the SEBI circular and Regulation 30 of LODR. The original copy of the order was sent by the CGST Department, Range 3, Baddi, through speed post on 23rd August 2024, which we received on 27th August 2024.

We would like to clarify here that the delay in intimation was totally unintentional and caused by the transition in our company's status and the subsequent changes in our communication channels. Please note that our company is a law abiding company and we assure you that we are taking all necessary steps to ensure such issues do not occur in the future.
